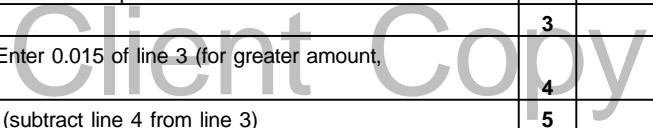

Homeless Outreach & Camp Visits: We check-in with our friends living outside and provide supplies such as replacement tents and sleeping bags. We have distributed 1,200+ new sleeping bags and 1,100+ new tents since 2015. We have helped 60 of our unsheltered neighbors end their homeless nightmare through stable housing.

New tents distributed - 42 tents (2020 - 108, 2019 - 113).

New sleeping bags distributed - 72 sleeping bags (2020 - 146, 2019 - 234).

Over 1,200 sleeping bags and 1,100 tents distributed since 2015.

Emergency Shelter Program:

We serve as an unofficial safety net to Richmond's shelter system and those homeless neighbors who are unable to access traditional shelter after hours or when it is full. We provide Emergency Motel Stays during dangerous weather, Dignity Motel Stays for those who have not bathed in weeks, and our Room in the Inn program at Christmas because no one should spend Christmas Eve and Christmas Night outside. In 2021 we provided 1,367 motel stay nights at a cost of \$94,937. Of the 195 individuals we sheltered, 113 were Henrico County residents, 70 were from Richmond, 11 were from Hanover, and 1 was from outside the area.

Unique children ages 0-17 - 44 children (2020 - 67, 2019 - 25).

Motel nights provided - 1,367 nights (2020 - 1,745, 2019 - 878).

Weekly Outdoor Community Outreach Events:

Our Saturday Servings are free events that provide a Hope and prayer, healthy lunches, health screenings, clothing, bike repairs, and assistance with Medicaid, SNAP, and replacement photos IDs. For many of our guests, these events provide a rare opportunity to socialize and fellowship, as many are seniors, disabled, and shut-ins. The hot meals we provide are prepared and served by groups from dozens of our incredible partner churches and businesses.

Since 2016, we have hosted over 300 weekly outdoor community outreach events in the Brookhill Azalea shopping center parking lot in Richmond. We had only cancelled one event since we began them in December of 2015, until the pandemic struck causing us to cancel three consecutive events while adapting our processes to social distancing requirements, masks, and more. Since resuming these events, the number of people we serve on Saturdays has exceeded pre-pandemic levels and continues to climb.

Through our partnership with FeedMore and the support of many churches, businesses, and individual donors, our mobile pantry provides each household enough groceries to prepare six meals. Our guest tallies continue to climb due to COVID, and we currently serve an average of 310 struggling neighbors each Saturday, rain or shine.

Our pantry operation regularly supports nine area food ministries and pantries with surplus bulk food we receive free from FeedMore and other sources.
