**Harley-Davidson® RIDE 365 – Annual Mileage Recognition Program**

**TERMS & CONDITIONS**

NO PURCHASE NECESSARY FOR ACTIVE HARLEY OWNERS GROUP® (“H.O.G.®”) MEMBERS TO PARTICIPATE IN THE H-D™ RIDE 365 ANNUAL MILEAGE RECOGNITION PROGRAM.

PROGRAM IS SUBJECT TO ALL FEDERAL, STATE, AND LOCAL LAWS AND REGULATIONS. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

YOU ARE PARTICIPATING IN THIS PROGRAM AT YOUR OWN RISK. ALWAYS RIDE SAFELY AND RESPONSIBLY.

**OVERVIEW:** Each new riding season brings excitement back to the road. Track your annual miles with authorized Harley-Davidson dealers to earn badges, certificates, patches, coins, and H-D Membership points after reaching the mileage milestones set forth in the table below.

**PROGRAM PERIOD:** The Annual Mileage Recognition Program (the “Program”) begins on January 1, 2024 and ends at 11:59 p.m. U.S. Central Time (“CT”) on December 31, 2024.

**ELIGIBILITY:** The Program is open to all H.O.G.® members (including Lifetime, Full Time members and Associate/Passenger members) who: (i) are legal U.S. residents; (ii) are 18 years of age or older and have reached the age of majority in their respective U.S. state of residence; (iii) have linked their H.O.G. ID to their H-D Membership account in the H-D app or online at HD.com/membership to enable earning points; and (iv) have received at least one mileage reading at a participating H-D dealership.

**GENERAL INSTRUCTIONS:** To participate in the Program, H.O.G. members will need to have the odometer of their motorcycles recorded at least two times a year at a participating H-D dealerships to determine their respective annual mileage – once on or after January 1, 2024 for an initial reading for the Program, and once on or before December 31, 2024 for the second reading. H.O.G. members will be automatically signed up to participate in the Program after the first mileage recording is taken. (Please note that other H-D™ Ride 365 activities, such as Ride 365 Destination Challenges, require H.O.G. members to enroll online at h-d.com/ride365.) The mileage earned between January 1, 2024 and December 31, 2024 – based on the difference between the earliest odometer reading in 2024 and the latest odometer reading in 2024 – will be used to calculate the total number of miles ridden in 2024. PLEASE NOTE: Odometer readings must be recorded by a participating H-D dealership, and only those odometer readings will be used for purposes of the Program. Sponsor reserves the right to disqualify or exclude any odometer readings that, in Sponsor’s sole determination and discretion, appear to be corrupted, altered, or otherwise irregular.

Eligible H.O.G.® members who ride the stated number of miles in 2024 will earn the following rewards at the corresponding milestones:

**ADDITIONAL TERMS AND CONDITIONS:** Individuals participate in the Program at their own risk. Please ride safely and responsibly at all times.

H-D will award H-D Membership points for up to 121,000,000 eligible miles ridden for the Program Period, based on the mileage milestones outlined in the table above on a first-come, first-served basis based on eligible mileage recordings. You may use H-D Membership points toward the purchase of eligible goods and services at authorized, participating U.S. HarleyDavidson® dealer locations and on h-d.com. H-D Membership points expire 36 months after issuance for all active U.S. H.O.G.® members. After the expiration date you will not be able to use the awarded points.

H-D Membership points will be awarded monthly based on available mileage recordings and will be fulfilled using the information provided by eligible H.O.G.® members to Sponsor and may take up to eight weeks from the mileage recording to be awarded.

*By way of example:*

*An eligible H.O.G. member rides 1,105 miles, having recorded their mileage twice at a participating H-D® dealership: once on January 28, 2024 for an initial reading and once on May 15, 2024, after riding 1,105 miles.*

- *H-D will issue 1,000 H-D Membership points on or around July 1, 2024 (expires on or around July 1, 2027; 36 months after they are issued)*

*An eligible H.O.G. member rides 7,950 miles and recorded their mileage twice at a participating H-D dealership: once on March 7, 2024 for an initial reading and once on October 13, 2024, after riding 7,950 miles. The same member rode an additional 2,082 miles and recorded their mileage again on December 8, 2024 at a participating H-D dealership, totaling 10,032 miles during the Program Period.*

- *H-D will issue 7,500 H-D Membership points on or around December 1, 2024 (expires on or around December 1, 2027; 36 months after they are issued) for the second reading from October 13, 2024.*
- *H-D will issue 2,500 H-D Membership points on or around February 1, 2025 (expires on or around February 1, 2028; 36 months after they are issued) for the third reading from December 8, 2024.*

H-D™ digital badges, certificates, patches, and coins have no intrinsic value (i.e., priceless). H-D digital badges will be fulfilled approximately twenty-four (24) hours after Sponsor receives qualifying mileage recordings. Physical items (i.e., certificates, patches, and coins) will be provided within twelve weeks following the end of the Program using the information provided by H.O.G.® members to Sponsor. To verify or update this information, call 1-800 CLUB HOG. Rewards are non-transferable, and no cash-outs will be provided. No substitutions of rewards will be provided unless determined in the sole discretion of the Sponsor. All taxes on rewards (if any) are the sole responsibility of participants.

Sponsor reserves the right to disqualify a participant or to exclude any miles that, in Sponsor's sole determination and discretion, appear to have been recorded incorrectly or that appear to be corrupted, altered, or otherwise irregular.

By participating, participants agree that they have read, accepted, and will abide by these Terms & Conditions and agree that any dispute with regard to the conduct of this Program, rule interpretation and application, the provision of rewards, or any other matter related to the Program, shall be submitted to Sponsor, whose decision shall be binding and final. Sponsor retains licenses, trademarks, and artwork to the digital badges, certificates, patches, and coins. Entrants are prohibited from recreating these items for personal or commercial use (e.g., making a physical or electronic version of the digital badges, certificates, patches, or coins) without express written permission from H-D.

**PUBLICITY RELEASE:** Except where prohibited, participation in the Program constitutes H.O.G.® members' consent that their name, likeness, voice, and/or biographical data may be used for advertising and promotional purposes without limitation and without additional notice, compensation, or consent.

**RELEASE OF LIABILITY:** By participating, H.O.G. members agree to release and hold harmless Sponsor, participating dealers and retailers, affiliates, sales representatives, distributors and promotional and other vendor agencies, their respective parent companies, affiliates, subsidiaries, service agencies, independent contractors, and the officers, directors, employees, agents and representatives of any of the above organizations involved in this Program (the "Released Parties") from any injury, loss or damage to person, including death, or property due in-whole or in-part, directly or indirectly, to participation in any Program-related activity or participation in the Program.
