Regular Board Meeting Minutes June 28, 2017

Opening:

The regular meeting of the Learning for Leadership Charter School Board was called to order at 6:05pm on 6/28/2017.

A. Approval of Agenda

<u>Director Reger made a motion to approve the agenda with second by Director Palmer.</u> The motion was put to a vote and passed unanimously 4-0, 1 absent.

B. Review/Approve Board Meeting Minutes

Director Henricks made a motion to approve the minutes for the 4/27/17 and 5/2/17 board meetings with second by Director Reger. The motion was put to a vote and passed 2-0, 2 abstain, 1 absent. Directors Moeller and Palmer did not vote because they were not board members as of the meeting dates.

F. Discussion with Pillsbury United Communities and Vote on Contract between LLCS and PUC

G. FY18 Budget: Discussion with Dawn Jenkins re the 2017-2018 School Budget and Approval of Budget

The budget was reviewed and discussed. <u>Director Henricks made a motion to approve the FY18 budget with second by Director Palmer.</u> The motion was put to a vote and passed unanimously 4-0, 1 absent.
