



## DANCE TEAM AGREEMENT

### 1. OBJECTIVE

This agreement delineates the expectations, duties, and commitments necessary for involvement in The Sophisticated Diamonds. By signing, dancers and their parents/guardians commit to adhering to the outlined policies.

---

### 2. ATTENDANCE & ENGAGEMENT

- \* Participation in all practices, rehearsals, performances, and competitions is compulsory unless prior notice is given.
- \* Any absences should be communicated to coaches at least 24 hours in advance, barring emergencies.
- \* Frequent absences (3 per month or 10 per season) could lead to:

- \* Loss of performance opportunities
- \* Removal from certain routines
- \* Expulsion from the team

---

### 3. PRACTICE GUIDELINES

- \* Arrival on time in the required attire: 6:30PM and Practice Uniforms
- \* Hair must be secured and kept out of the face; all jewelry must be removed.
- \* Dancers must bring appropriate footwear, equipment, water, and any assigned items.
- \* Mobile devices must be turned off or silenced during practices.

---

### 4. CONDUCT & BEHAVIOR

- \* Dancers are expected to show respect toward coaches, teammates, judges, and staff at all times.
- \* Bullying, harassment, gossip, or any form of disrespect will not be tolerated.
- \* Dancers represent the team at all times, including on social media. Inappropriate posts may lead to disciplinary measures.

---

### 5. UNIFORMS & COSTUMES

- \* Uniforms, costumes, and accessories must be maintained in a clean and presentable condition.
- \* Lost or damaged items may need to be replaced at the dancer's expense.
- \* Costumes should not be worn outside of team functions without prior coach approval.

---

## 6. FEES & FINANCIAL OBLIGATIONS

Parents/guardians agree to cover all required fees, including but not limited to:

- \* Registration: \$25
- \* Tuition: \$65-\$85 per month
- \* Costumes: \$170 stand battle, \$150 Pompom
- \* Competition Fees: \$ varies
- \* Travel Expenses: Estimated \$ TBA

Payment deadlines: Stand Battle uniform (01-09-2026), Pom Pom uniform (01-30-2026)

Late payments may lead to suspension from team activities.

## 7. COMPETITIONS & EVENTS

- \* Attendance at all required competitions and events is mandatory.
- \* Dancers should arrive at the designated time with all necessary costumes and materials.
- \* Parents/guardians are responsible for transportation unless alternate arrangements are made.

---

## 8. INJURIES & HEALTH CONCERNS

- \* Dancers must report any injuries to coaches immediately.
- \* A coach may require a medical clearance before a dancer can resume practice or performances.

\* The team/studio is not liable for injuries sustained during team activities, to the fullest extent allowed by law.

---

## 9. PARENT/GUARDIAN RESPONSIBILITIES

Parents/guardians agree to:

- \* Support their dancer's involvement.
- \* Communicate respectfully with coaches and staff.
- \* Avoid coaching their dancer from the sidelines.
- \* Abide by all event and studio policies.

---

## 10. DISCIPLINARY MEASURES

Coaches may implement one or more of the following actions:

1. Verbal warning
2. Written warning
3. Removal from routines
4. Suspension from team activities
5. Dismissal from the team

---

## 11. DURATION & TERMINATION OF CONTRACT

This agreement is effective from 12/2025 to 12/2026.

Early withdrawal may result in losing any fees already paid.
