Abstract: The dissertation defends the Rawlsian focus on the basic structure of society as the primary subject of justice. It explains what the basic structure is and why it is morally significant. By structuring our interaction with others, our basic institutions do not merely cause certain distributions, they often determine our moral obligations, our rights, and our values.

- TEACHING EXPERIENCE

Political Economy (Senior PPE Seminar)

(Spring 2021, 22; Fall 2022, 23, 24, 25)

- A senior seminar focused on discussion of interdisciplinary topics and writing a final research paper. Topics include analyses of economic systems, public choice theory, and public reason.

Social and Political Philosophy

(Spring 2025; Fall 2022, 23, 25)

- Focuses on key historical texts to bring out trends in philosophy about government authority, economic justice, and social oppression (from Hobbes to Kimberle Crenshaw)

Ethics and Civic Life

(Fall 2019, 20, 21; Spring 2024, 25)

- By focusing on specific policy debates (esp. minimum wage, trade, and immigration), this class highlights how ethical theory interacts with social science to argue for or against specific policies.

Socialism vs. Capitalism (First Year Seminar)

(Fall 2024)

Focus on debates about economic systems including Smith, Marx, Lenin, Dubois, Keynes, Hayek,
 Meade, and 21st century writers. The focus is on systems that are between Capitalism and Socialism.

Philosophy of Law

(Fall 2016, 17, 18, 19, 21, Spring 2023)

- A survey of both analytic and normative problems in Tort Law, Contract Law, Criminal Law, Property Law, and Constitutional Law. Specific Supreme Court cases are used throughout.

Capitalism, Equality, and Justice

(Fall 2020)

- Surveys historical and contemporary arguments for and against Capitalism with emphasis on Smith, Marx, feminism, and economic development.

Social Ethics (Spring 2019)

- Introductory ethics class on individual responsibility for collectively harmful behavior such as consumer choices and sustaining harmful norms.

Environmental Ethics (Spring 2019)

- Upper level Philosophy and PPE course that focuses on ethical difficulties in the treatment of natural environments (with emphasis on policy decisions).

Introduction to Ethics

(Fall 2014, 16, 17, 18; Spring 17)

- Focuses on developing skill in ethical reasoning by reviewing key ethical distinctions, applied topics, and major moral theories.

Law and Ethics of Cyber Espionage

(Fall 16, 17; Spring 2017, 18)

- Evaluates the policy and law that surround state-on-state, state-on-person, and company-on-company espionage with a special focus on cyber-espionage.

Political Ethics (Spring 2018; Fall 2012)

- Applied ethics with focus on moral issues faced within political institutions. The class starts with ethics for legislators, then on to questions about voting, following the law, and judicial ethics.

Theories of Justice (Spring 2017)

- Starting with contemporary debates, this class introduces political theories with a focus on Hobbes, Locke, Rousseau, Mill, Smith, Marx, and Rawls.

Ethics of Peace, War, and Defense

(Summer 2016; Spring 2016)

- Teaches the basics of and alternatives to just war theory before applying these ideas to contemporary topics like drone use, targeted killing, and secrecy.

Introduction to PPE

(Fall 2014, 2015; Spring 2015)

- Examines rational choice theory, game theory, public choice theory, norms theory, and principles of distributive justice as introductory PPE class.

Capstone Seminar in PPE

(Spring 2015, 2016)

- Senior research seminar PPE program. Topics include cost-benefit analysis, public choice theory, the value of democracy, and measures of well-being.

The Social Contract (Summer 2012)

- A class that contextualizes and explains the historical development of the Social Contract through Hobbes, Locke, Rousseau, Kant, Rawls, and Charles Mills. The approach is contrasted to alternatives.
