

Tuition and Incidental Fees/ Volunteer Hours

To our HCA Family:

HCA is pleased to be able to offer tuition rates that are less than half of the state average for a parochial school education, but to continue to keep our tuition low we must be able to depend on a consistent income to pay our bills and faculty. The Board of Education, acting out of concern for the financial health of our academy, has adopted new guidelines regarding the payment of tuition.

For the 2024-2025 school year, HCA utilizes mandatory automatic monthly tuition and fee deductions from your bank account or credit card. We implemented this payment method to offer convenience and simplicity for all of our busy families. Please complete a form for each student in your family and submit to become enrolled at HCA.

Here's How Recurring Payments Work: You authorize regularly scheduled charges to your checking/savings account or credit card. You will be charged the amount indicated below each billing period. There will be a convenience fee of 1% for ACH (Checking or Savings Account) and 2.9% + \$0.30 for Credit Cards. The automatic deductions will be handled by a third-party company by the name of STRIPE. Ask the administrator to view the status of your school account. The charge will appear on your bank or credit card statement as HCF 480-895-0627. You agree that no prior notification will be provided unless the date or amount changes, in which case you will receive notice from us at least 10 days prior to the payment being collected.

Families should fill out the Financial Recurring Payment Authorization Form for monthly payments to be automatically withdrawn from a checking or savings account. The program not only offers the school financial stability but also simplifies your life and helps you to be the dependable person you want to be.

Thank you to our wonderful school parents for joining us in this effort to raise our standard of financial stewardship. We look forward to helping your children spread their wings and soar!

Tuition

- A 5% discount will be given if tuition is paid in full by July 1st. This only applies to families paying entire tuition with no scholarship or outside funding.
- Before the last payment of this school year, we will let each family know the amount of credit/debit they've accumulated through and the fee for not completing the required volunteer hours, so the last payment can be modified accordingly.

The Tuition schedule is as follows (with \$25 non-refundable application fee for new students):

Payment Options:

- Pay in full by July 1st (receive 5% discount if not receiving scholarship or other funding)
- OR complete Financial Agreement Form for automatic deductions to be made from your bank account.

Financial Help:

- All families K-8 may apply for a scholarship from Hillman Christian Family. However, families will be asked to seek assistance (scholarship aid) first from their own congregation.

Required Volunteer Hours:

- **All** Hillman Christian Academy parents are “Parents **for** Hillman Academy,” and the expectation is that all parents *want to and do* support the academy at least 10 hours a month in whatever ways God has gifted them to do so. There are many opportunities to be involved in Hillman Christian Academy. The organizational system supports each member as he or she works toward the vision of Hillman Christian Academy.
- NOTE: Mid-year arrivals will be prorated by date.
