## Meet Jeanne Smith

Jeanne Smith, age 94, came to Dixon House in August 2019 to be close to her daughter who lives in Easton.

She was born in St. Michaels on Thanksgiving Day in 1927 and guips that her mother never got the Thanksgiving dinner she cooked that day because Jeanne decided to be born. She had one sister Charlotte and her family lived with her grandmother in St. Michaels. Jeanne loved sailing and sailboat racing as a younger woman. Early on, she wanted to be a nurse but her mother discouraged her and she became a secretary instead. She married Russell Smith after meeting him on a blind date.

Russell was a marine who served in World War II and later was a Deputy Sheriff. The couple had three children while living in Easton — Susan, Butch, and Sylvia.

Jeanne is talented both musically and as a quilter. Just stop by her room on the second floor of Dixon House and you will see the fruits of her labor — beautiful quilts adorn her walls and her bed. She even has a book of all the quilts she made, telling their stories and who she made them for. As a member of Bayside Quilters, Jeanne exhibited a number of her quilts. One of her quilts is made from one-of-a-kind embroidered tea towels.

"I started sewing aprons first. I made my first quilt in 1993 and it's the one on my bed. I made quilts mainly for my family — for all of my children and my nieces," she shares.

Jeanne learned how to play music from her mother who was a piano teacher. She learned to play the accordion and even had a music partner who played the mouth organ. When she came to Dixon House, she brought her accordion with her to play.

She started her career in secretarial work, first with Gulf Oil Corporation, then with Campbell Ensor Advertising, before working as an administrative assistant in Nursing Administration at Memorial Hospital in Easton (now the University of Maryland Shore Regional Health) — the position from which she retired. She and her husband enjoyed their travel camper and going to Florida. Jeanne later took trips to Iceland and the Hawaiian Islands.

Jeanne likes to read and enjoys the exercise classes and other activities offered at Dixon House. She also appreciates her church providing a bus to pick her up weekly to attend church.

"Dixon House offers affordable housing for seniors like me — they provide our room, meals, entertainment, and activities. Plus, it's convenient for my family and I really like the people who work here," she adds.




