DISCUSS INCREASE IN CAMPING FEES AT SHADOWROCK PARK

On a motion by Scott Novak and seconded by Dennis Winzenried it was approved to amend ordinance 569 to allow campers to use the golden life time pass at Shadowrock Park to receive half price camping rates, also the campground will give discounts of half price camping to members of the military. DISCUSS TERMS OF LEASE WITH VERIZON – TOWER SITE BY THE SCHOOL

The city has been contacted by Verizon and is wanting a lower lease amount for their equipment on the tower by the school. The board would like the city attorney to review the lease option and will discuss at the June 17, 2024 board meeting.
