# SIGNED - IN SPEAKERS

Roxanne Amundsen and Elizabeth Hughes spoke to the board about the Ozark Mountain Christmas. They would like the city to join the Branson Christmas Coalition. Being a part of the coalition would help Forsyth with getting the Christmas light display underway.

John Farmer La Torrel explained to the board that he is with the Ozark Film Co-op. He would like the board to sign an endorsement that shows the city supports the Ozark Film Co-op.

On a motion by Dennis Winzenried and seconded by Scott Novak it was approved to sign the endorsement pending the approval of the city attorney. Motion carried with all members present voting aye.

Shelia Wyatt explained the use tax. The use tax is on items purchased from out of state. It is the same tax that you pay on an item at a store in town. This will level the playing field for people that pay tax in town. The tax will be used to maintain the revenue of the city and will help better serve the community.

# ARCHERY COMPETITION PRESENTATION

Dave Wilson with Shiloh Archery addressed the board about having an archery event at the gateway bike trail. They would like to hold the event one day a month from January through July. They will set up for the event on Friday evenings and hold the event on Saturday.

#### POLICE CHIEF UPDATE

Police Chief Pat Gray explained that sidewalks and lighting are needed along highway 160 by the Woodlands apartments. There have been several accidents in this area. We have several special events coming up in the spring. The police department has seen an increase in animal calls this year.

# FIRE CHIEF UPDATE

Fire Chief Nathan Bower explained that the fire department has responded to 132 calls so far this year. Have several training sessions coming up. Will hold a training session for the public works department on CPR and fire extinguishers. Still working on moving the fire reports onto a new database.

# ACCEPT GRANT FROM WHITE RIVER ELECTRIC TRUST & APPROVE BID FOR I-PADS

On a motion by Shawn Mathenia and seconded by Dennis Winzenried it was approved to accept the grant from White River Electric Trust and accept the bid from Verizon for eight I-pads in the amount of \$399.00 per I-pad. This will help with mapping in the fire vehicles and will be hands free. Motion carried with all members present voting aye.

# APPROVE RENEWAL FROM VFIS – ACCIDENT PROGRAM FOR VOLUNTEER FIREFIGHTERS

On a motion by Shawn Mathenia and seconded by Dennis Winzenried the renewal from VFIS for the accident program for the volunteer firefighters was approved in the amount of \$2,491.00. Motion carried with all members present voting aye.

# APPROVE BID TO PURCHASE 40 FOOT STORAGE CONTAINER FOR THE FIRE DEPARTMENT

Fire Chief Nathan Bower explained that a container is needed for storage space and will be paid for out of the fire tax. He received two bids for the container, Superior Containers for \$3,100.00 and Boxhub for \$3,580.00. On a motion by Shawn Mathenia and seconded by Dennis Winzenried it was approved to accept the bid and purchase the container from Superior Containers in the amount of \$3,100.00. Motion carried with all members present voting aye.

#### CITY ADMINISTRATOR UPDATE

City administrator Jim Viebrock explained that he has hired four new employees in the public works and recreations departments. The aerator at the treatment plant is in process of being rebuilt. Public works have been replacing some troublesome water meters with new electronic read meters.
