## DISCUSS FENCE ISSUE AT 151 PINE STREET

Building Inspector Will Mattegat explained that have an issue on Pine Street and Lincoln Street concerning a fence location. The owner is concerned about property lines and roadway locations. There is also a main water line in this area. The guideline the board feels should follow would be to allow the fence to be built 15 feet from the center line of the main water line on the owners property, and use existing ordinances as guidelines.

### DISCUSS SHADOWROCK LODGE DEBRIS DISPOSAL OPTIONS

Fire Chief Nathan Bower explained that he has been working with some possible future owners of Shadowrock Lodge. They would like to tear down the motel section. Would need a location to take the debris. There are two areas in town that maybe used for the debris. The public works maintenance shop on Blair and the fairgrounds on Hwy 76 are the two locations the debris can be dumped.

### DISCUSS SHADOWROCK LODGE DEMO PERMIT

On a motion by Dennis Winzenried and seconded by Missi Hesketh it was approved to waive the demolition permit fee for the demolition of the motel section of Shadowrock Park, and to waive the demolition permit fee for any first time demolition permit fee for buildings that are determined to be dangerous buildings. Motion carried with all members present voting aye.

#### DANGEROUS BUILDING DISCUSSION

Fire Chief Nathan Bower is looking for guidance from the board on dangerous buildings in town. The board would like to see a list of properties ranked with the worst conditions to consider first. Notify the owner by letter and if no response a ticket from the police department may be sent if deemed necessary. Also, need to revise the ordinance concerning dangerous buildings to read building inspector instead of City Engineer. Fire Chief Nathan Bower, Building Inspector Will Mattegat, and Attorney Bill McCullah to work together on revising the ordinance.

#### DISCUSS ORDINANCE REVIEW PROCESS

The board had open discussion on the current ordinances. Some are outdated and need to be revised or repelled. Aldermen Dustin Krob to present a list of ordinances for the next meeting in August for review and repelled if needed.

Also, discussed allowing chickens in town. Dustin Krob and Missi Hesketh to work together on a sample ordinance for the board to review. The board would like to have a survey on this months water bill concerning chickens. The mayor invited anyone against chickens to come to the next meeting in August.

The ordinance on living in a camper on your property was also discussed. There has been some expressed interest in staying in a camper while a house is being built and an active building permit has been issued. Fire Chief Nathan Bower, Building Inspector Will Mattegat to draft an ordinance for review at the next meeting in August.

Missi Hesketh gave an update to the board on the parks. The trail project is moving forward. She stated she will be attending a trail task force meeting next week. There are grants available for trail projects and will be working with Debbie Redford on grant options. Also, would like the boards thoughts on a music festival and having alcohol at the event.
