She has visited with the Boys and Girls Club about an agreement with them on the trail property. The Boys and Girls Club is concerned about the liability insurance on the trail property.

The proposal cost of \$15,167.00 to be paid out of ARPA funds. Motion carried with all members present voting aye.

GATEWAY TRAIL DEDICATION

SHOALS BEND ADA COMPLIANCE UPDATE

Missi Hesketh explained that the Shoals Bend Park needs some ADA improvements. Would like to have handicap parking spaces put in at the park and look into options for smooth surface material around the playground equipment, and a smooth path from the parking lot to the playground equipment. The public works department made some ADA upgrades to the bathrooms at Shoals Bend Park and installed a water bottle refill station.

COMMUNITY SERVICE WORK PROGRAM FOR JUVENILES

APPROVE COUNTY SEWER RATE INCREASE

On a motion by Dennis Winzenried and seconded by Dustin Krob it was approved to increase the rate of service to the Taney County Regional Sewer District in the amount of .35 cent per thousand gallons treated for 2023. Motion carried with all members present voting aye.

APPOINT ALTERNATE TO BIO SOLIDS BOARD
