UPDATE FROM FAIR BOARD

Quinton Gideon with the fair board explained that they have hired a grounds keeper for the area. Will have an area for the county to dump and make a place for the city to dump. These areas will not be for public use. Will be providing a place to dump the materials from the Shadowrock Lodge. Will be having several events and would like to help with the city Easter egg hunt.

UPDATE ON SHADOWROCK LODGE

Fire Chief Nathan Bower explained that the owner has a signed contract with Turners Heavy Equipment Company LLC to remove the building and is waiting on a contract with Sunbelt for the asbestos removal.
