APPROVE CONTRACT AND PRICE CHANGE FOR GATEWAY TRAIL AND APPROVE ADDITIONAL FUNDING AND AUTHORIZE MAYOR TO SIGN DOCUMENTS

The board was presented with an updated contract from Reserve Concepts for the Gateway Trail that includes prevailing wage. Adding prevailing wage increased the contract by \$133,310.12.

On a motion by Dennis Winzenried and seconded by Dustin Krob it was approved to accept the contract from Reserve Concepts and to use the recreation fund for the additional funds in the amount of \$133,310.12 and authorize the Mayor to sign the contract. APPROVE HIRING PUBLIC WORKS EMPLOYEE

MUNICIPAL EMPLOYEE RECOGNITION WEEK MAY 7- MAY 13 AND APPROVE TRUMAN DAY AS A PAID HOLIDAY FOR EMPLOYEES

Mayor Hesketh explained that May 7th thru May 13th is Municipal employee recognition week. Would like to have a lunch sometime that week to show appreciation to the City employees. Also, would like the board to consider giving the employees a paid day off on May 8th for Truman Day.

Shadowrock Park and the lease addressing possible financial help from the Corp for flood clean up.

APPROVE FIRE FIGHTER APPLICATION

On a motion by Scott Novak and seconded by Dustin Krob it was approved to accept Maddex Kinsey as a fire fighter for the Forsyth Fire Department. Motion carried with all members present voting aye.

FIRE CHIEF UPDATE - ISO UPDATE, DANGEROUS BUILDING UPDATE, STORM READY RENEWAL

Fire Chief Nathan Bower gave the board an update on the ISO rating. The City's rating is 4 at this time. The department is working on a plan to increase the rating. Chief Bower explained the progress on several dangerous buildings. The Shadowrock Lodge should be ready for demolition in about two weeks. Chief Bower presented the board with a Storm Ready Renewal Recognition Certificate.

APPROVE BIDS FOR A COPY MACHINE FOR POLICE DEPARTMENT AND FIRE DEPARTMENT

Chief Bower explained that he received bids from two companies for black and white copier and color and black and white copier. Chris Logue with Great Escapes explained that they have had some problems with vandalism and things getting stolen from the campground. Would like to put up a fence to help provide a safer environment for their guests. The fence would run from the corner of the water tower to the ballfield and from the field to the communication tower. The cost of the fence is \$9,960.00.
