DISCUSS AND REVIEW SPECIAL EVENT POLICY

DISCUSS STREET LIGHT ON HWY 160 NEAR WOODLANDS II ENTRANCE

There are concerns about it being very dark along Highway 160 at the Woodland II entrance. FIRE ARMS TRAINING - CHIEF PAT GRAY

Chief Gray explained that the department does not currently have ready access to a high quality shooting facility for firearms training and qualifying of its sworn officers.

He recommends that the department join the Throp Creek Range as a Founding Group Member. The department will have 10 roster spots. The fee for joining is \$2,500.00. The department will be billed \$100.00/year per rostered member. Thorp Creek will waive the yearly fee for any member on the roster that volunteers to serve as on-site range officer for 1 day, 10:00 am to 4:00 p.m. per calendar year.

DISCUSS MODOT GROWING TOGETHER AGREEMENT

Public works supervisor Steve Marler has been in contact with MoDot about the roundabout at Hwy 160 and Hwy 76. We will need a Growing Together Agreement with MoDot to be able to plant flowers, plants, and shrubs in this area. Will be working with Beth Shaller with MoDot to get the agreement in place.

DISCUSS USTA GRANT OPPORTUNITY

The Mayor explained that she has been in contact with the US Tennis Association about reconstruction of the tennis courts in Shadowrock Park. The USTA will come to the park and look at the tennis court and determine what needs to be done to the tennis courts.
