DISCUSS PURCHASING SIGNAGE FOR STREET PARKING

The Mayor explained that in order to enforce no parking on the streets the city must have no parking signs in place. Parking on the streets is a problem for snow plows and emergency vehicles. The police chief and fire chief would like to visit with some of the neighborhoods about this problem and determine where the signs are needed and how many signs need to purchase. To have more information for the board at the meeting in February.

POLICE CHIEF UPDATE

Police Chief Pat Gray explained that the overall crime rate is down in the area. He will be going to Joplin for a hiring fair. Some departments have a program that the City would pay for the officers training and the officer sign a three year contract to work for the city.

On a motion by Dennis Winzenried and seconded by Dustin Krob it was approved to pay 1/3 of the tuition fee for three years. To pay 1/3 each year for three years. The officer must sign a three

year contract with the City. There will be \$15,000.00 limit to the overall tuition cost. Motion carried with all member present voting aye.

APPROVE TO PAY SOUTHWEST MO COUNCIL OF GOVERNMENTS (SMCOG) YEARLY MEMBERSHIP FEE OF \$1,250.00
