The board is willing to work with the riding club and Sarah to meet with city administrator Jim Viebrock to draft an agreement for the use of the arena. The board gave Sarah permission to put a banner on top of the pavilion at the park.

DISCUSS TERMS OF LEASE WITH VERIZON - TOWER SITE BY SCHOOL

CITY ADMINISTRATOR UPDATE

City Administrator Jim Viebrock gave the board an update on the overall operations of the city. The staff will be working on the 2025 budget, public works will be working on DNR licenses and CDL licenses. The building department is working on dangerous buildings and will be working with staff on several projects.

POLICE CHIEF UPDATE - DISCUSS BODY CAMERAS AND LEXAPOL PROGRAM

Police Chief Pat Gray explained that have had several calls for service and assisted the County with some calls. Would like the board to consider purchasing body cameras. The cameras the department currently has are outdated or don't work at all.

He received a bid for the body cameras from Motorola Solutions for a five year plan for \$26,280.00. Motorola is the only source for the cameras. This is for six cameras and there is a five-year warranty.

On a motion by Dennis Winzenried and seconded by Shawn Mathenia it was approved to purchase the body cameras from Motorola in the amount of \$26,280.00 for a five-year program. Motion carried with all members present voting aye.

The chief also like the board to consider the Lexapol program for next year's budget. This program takes care of the policy and procedures for the police department.

APPROVE TO PURCHASE TRAINING FIRE EXTINGUISHER

Fire Chief Nathan received two bids for a training fire extinguisher. Sentinel Emergency Solution for \$13,060.00 and Zero Emissions for \$15,013.99. On a motion by Scott Novak and seconded by Shawn Mathenia it was approved to purchase the training fire extinguisher from Sentinel Emergency Solutions in the amount of \$13,060.00. Motion carried with all members present voting aye.

APPROVE BID FOR WATER TOWER CLEANING AND INSPECTION

The city received two bids for cleaning two water towers and inspecting all of the towers. Hogans Painting & Sandblasting for \$19,450.00 and Ozark Applicators for \$28,050.00. On a motion by Shawn Mathenia and seconded by Dennis Winzenried it was approved to accept the bid from Hogans Painting & Sandblasting in the amount of \$19,450.00. Motion carried with all members present voting aye.

BUDGET AMENDMENT

Due to the decisions on purchases and projects discussed at this meeting staff will have an updated budget amendment for the board to approve at the August 19, 2024 meeting.

DISCUSS TRANSFERRING MONEY FROM MOSIP TO BRANSON BANK

The board had a discussion on moving money from MOSIP to Branson Bank. Scott Novak made a motion to table this indefinitely with a second by Shawn Mathenia with the following votes taken: Scott Novak, aye, Shawn Mathenia, aye, Dennis Winzenried, nay, and Dustin Krob, absent.
