BUILDING INSPECTOR UPDATE

Building Inspector Will Mattegat explained to the board that he has 31 open permits and 10 open permits on dangerous buildings. The Forsyth School has turned in an application for a permit for an indoor activity center and gym.

FIRE CHIEF UPDATE

Fire Chief Nathan Bower explained that he has 24 active volunteers, and the department has had 474 calls for service so far this year. The smoke detector program is in place and the department will install smoke detectors for free. Contact the fire department if you need a smoke detector.

APPROVE TO PURCHASE DECALS FOR THE NEW FORD TRUCK - FIRE DEPARTMENT

Fire Chief Nathan Bower explained that he received several bids for decals for the truck. Some bids were for repainting the truck and others for a wrap. APPROVE TO PURCHASE FIRE DEPARTMENT RECORDS MANAGEMENT PROGRAM

Chief Bower explained that the current management program expires at the end of the year would like to with a different program thru First Due in the amount of \$8,900.00 for one year. On a motion by Scott Novak and seconded by Shawn Mathenia it was approved to accept the bid from First Due in the amount of \$8,900.00 for one year.

CITY ADMINISTRATOR UPDATE

City Administrator Jim Viebrock explained that the scada program for the sewer lift stations is in the construction stages. The pickle ball nets have been installed and will be working on new LED lights for the tennis courts in Shadowrock Park. Will be working on a program to update the Christmas decorations and drive thru light display in Shadowrock Park.
