He has been looking into security options for special events. The security needs to be based on what type of event is being held. A rodeo or demolition derby that serves alcohol would need more security than a craft show. He will be working on the security plan for the special events and updating the special event application.

CITY ADMINISTRATOR UPDATE – EMERGENCY MANAGEMENT STUDY SESSION

City Administrator Jim Viebrock gave the board an update. Have been working on cleaning and inspecting the water towers. Will be working on mapping system for the water and sewer lines. The electrical part of the sewer lift station monitoring system is being installed. The flood damage at the treatment plant has been repaired. Will be working on an emergency plan in case of a power outage or storm.

On a motion by Dennis and seconded by Shawn Mathenia it was approved to appoint City Administrator Jim Viebrock to the SW Missouri Solid Was'te Management District N Council and appoint Dennis Winzenried as the alternate. Motion carried with all members present voting aye.

APPROVE TO CONTINUE THE LEASE FOR THE MINI X WITH BRANSON BANK
