#### FIRE CHIEF UPDATE

Fire Chief Nathan Bower explained that the department has 13 firefighters, 7 support members, and 2 junior firefighters at this time. They responded to 498 calls for service in 2024. The department is working on some grants, hosting training classes, fire hydrant maintenance program, and other projects. The decals have been put onto the new staff vehicle.

#### CITY ADMINISTRATOR UPDATE

City Administrator Jim Viebrock explained that the public works department has installed new heaters in the restrooms at Shadow Rock Park. Public works will also be working on removing stumps in the park. The first lift station will be on the new monitoring system soon. Will be working on a fireworks display and a Christmas light display.
