I write to you not just as a journalist, but as a committed protector of truth, a neurodivergent human being in recovery, and an architect of ethical systems meant to serve the next evolution of journalism.

After more than 25 years in field journalism, including war coverage and disaster response, I officially retired following the February 2023 earthquake in Turkey. Since then, I've transitioned into developing AI-based journalism ethics, advocating for radical transparency and the creation of protective frameworks for independent journalists worldwide.

On the day in question, I was parked legally in a designated disabled space at: Carrer de los Castillejos 405, Horta-Guinardó, 08025 Barcelona

I suffer from multiple medically diagnosed conditions, including Autism Spectrum Disorder (ASD Level 1), severe ADHD, and Chronic PTSD. I am officially recognized as disabled under EU law and carry a legal prescription for medical cannabis. On this particular day, I was in a state of acute pain, having recently lost several teeth from advanced gingivitis and was in no condition to engage in conflict or movement without risk of collapse.

As I sat in my vehicle, a man pulled up directly behind me, effectively trapping me in the space. While on the phone with my partner of four years, Jana Dunne, I politely asked, "Un momento, por favor." Instead of waiting or responding respectfully, he and two others began shouting aggressively at me. Despite showing my press credentials and disability card, I was met with hostility and increasing psychological distress.

My vehicle was towed by municipal police. I was left standing in pain, with my condition worsening—and more devastatingly, my official press ID was lost by the authorities during this process.

Further investigation revealed a deeper systemic failure: In Barcelona, many disabled parking spaces are registered to individual residents, despite appearing public. This creates a legal and moral contradiction—EU disability laws guarantee universal access, not conditional permission based on residence. This privatization of disability rights is exclusionary, unclear, and leads to conflict—especially for visiting professionals with legally recognized disabilities.

I respectfully request the following from the Federation:

1. Recognition of this incident as a violation of journalistic freedom and disability rights.

2. Immediate reissuance of a valid International Press Card, to replace the one lost.
3. Registry of this event as a documented case of obstruction against a neurodivergent journalist.
4. Public pressure on the Catalan government to reform discriminatory disability access policies.
5. Full recognition of journalists working in ethical, post-field, or AI-driven reporting as equals under international protection standards.

I am prepared to submit all supporting documents:

- Police reports
- Translated legal complaints
- Medical records and prescriptions
- AI-authenticated logs and time-stamped incident data
- Voice and video files if needed

I continue my work—not in war zones—but in digital ones. Still fighting. Still reporting. Still healing.
