## **ALPHA SIGMA PHI** FRATERNITY CED REPORT **JANUARY 2021**

Alpha Sigma Phi grieves for the brothers lost due to COVID-19 and empathizes with our brothers who've lost loved ones because of COVID-19. We wish those grieving peace and comfort during these most difficult of times. The Fraternity also thanks our brothers who are frontline healthcare workers for tirelessly fighting for lives and defeating this virus.



It's been about a year since we first began hearing about the novel Coronavirus, and little did we know the impact we'd endure, both in immediacy and in severity. This pandemic has impacted EVERY individual and EVERY industry on the planet, and Alpha Sigma Phi has been no exception. Thank you to our volunteers and advisors for helping us navigate this unprecedented circumstance.

#### RECRUITMENT

Fewer new members joined Alpha Sigma Phi in the fall than in recent years, which is expected in the climate of a global pandemic. However, the Old Gal recruited more men than the budget projected over the summer and membership numbers were on par with our peers.

#### CHAPTERS

Only one chapter has closed in the past nine months. That campus, however, has agreed to have Alpha Sigma Phi return within the next couple of years.

#### FINANCE

Alpha Sigma Phi has not raised its membership fees and still offers a Price Match Guarantee. The Fraternity reduced expenses (reduced travel, no Grand Chapter) which has allowed us not to have to dip into our Reserve Fund.

#### **CLVEN HOUSING**

The fall 2020 term was the first in its existence where CLVEN was cash flow positive. Furthermore, 95% of anticipated residents moved in and lived in a CLVEN property last semester.

#### **HEALTH & SAFETY**

Alpha Sigma Phi reported zero major COVID-related incidents/outbreaks during the fall term, in large part because of extensive coaching and education by Fraternity Staff over the summer and fall.

- Increase the number of Manigault Society Members (Society for members who have left Alpha Sigma Phi Foundation in estate provisions or as a designated beneficiary of a retirement account/life insurance policy, etc.).

- CLVEN will enhance the undergraduate fraternity experience by owning or managing a chapter facility or shared space on every viable campus where Alpha Sigma Phi has an active chapter.
- CLVEN will generate revenue to have adequate resources to achieve the Purpose of the organization.
- CLVEN will foster an environment conducive to academic success and brotherhood development for all owned or managed properties.

The 2025 Strategic Plan is the first in our history that all three entities of Alpha Sigma Phi (Fraternity, Foundation and CLVEN) have their own priorities and objectives. This process began after the election of our 41st Grand Senior President, Jeff Hoffman, Member-at-Large '76, and was approved by each Board in 2020.


## DEPARTED
