## The NSW Roadside Environment Committee

---

The NSW Roadside Environment Committee (REC) was established in 1994 by the NSW Government in recognition of the environmental values of linear reserves. The REC is an umbrella body of state agencies and environment groups that promotes and coordinates leading practice in linear reserve environmental management across the State.

**The vision of the REC is:  
Environmental values of linear corridors are actively managed in  
balance with other functional needs.**

The REC currently comprises thirteen organisations with interests in the management of roadside and other linear reserves in NSW. The REC member organisations are:

## Key issues

In developing its 2016-19 Strategic Plan, the REC identified the following key issues that it will focus on.

## Achievements

In 2019-20, the REC carried out actions related to the 2016-19 Strategic Plan which was extended to cover this financial year. These actions included:

- Organising and running a forum showcasing environmental management of linear reserves (Action 3.4 in the Strategic Plan). The one-day forum was held in August 2019 for land managers and others interested in linear reserve environmental management.

The theme of the forum was 'Linear Reserves: Linking People, Nature and Infrastructure'. Keynote speakers had a mix of research and practical linear reserve experience and included Dr Peter Spooner of Charles Sturt University, a leading researcher into the environmental history and management of linear reserves in Australia and Mr Pat Connor, a civil engineer with a background in gas pipeline and road construction.

The forum included presentations on improving practices and case studies on themes including 'Taking Stock', 'Systems and Data', and 'Innovation'. An interactive panel session at the end of the forum allowed participants to ask questions to the experts in the field.

## Information/Content

The forum was attended by 98 representatives from local councils, government agencies and other organisations. A further 20 presenters attended.

Overall, participants' evaluation of the forum was very positive, and several requested that another forum be run within the next two years.

- Supporting and promoting the Linear Reserves Program funded by the NSW Environmental Trust (Action 1.1). The Linear Reserves Program consists of two programs:
  1. Managing Travelling Stock Reserves for Sustainable Conservation Outcomes managed by LLS in conjunction with OEH (\$4.75 million over three years).
  2. Council Roadside Reserves Project managed by LGNSW (\$2.08 million over three years).
- Sponsoring the Roadside Environmental Management Award as part of the 2019 Local Government Excellence in the Environment Awards initiated by LGNSW (Action 3.5).

The Awards are open to all local councils and council organisations in NSW and aim to recognise outstanding achievements by NSW Local Government in managing and protecting the environment.

The REC has sponsored the Roadside Environmental Management Award for the past nine years.

The Winner Division A (councils with smaller populations) and Overall Winner of the NSW Roadside Environmental Management Award was Griffith City Council for its project 'An innovative solution to measuring and revaluing Griffith's roadside reserves'. Bellingen Shire Council was highly commended in Division A for its project 'Bellingen Roadside Environmental Management Plan'.

The winner of Division B (councils with medium-sized populations) was Wingecarribee Shire Council for its 'Integrated Roadside Environmental Management Framework'. The Division C (councils with larger populations) winner was Coffs Harbour City Council for 'Roadside vegetation as a natural asset - a pilot'.

- Sharing and learning more about aspects of linear reserve management including new biosecurity and biodiversity conservation legislation, review of crown lands, the review of travelling stock reserves, and new methods for environmental management (Actions 2.1, 2.2 and 2.5).
- Implementing the REC Communication Plan (Action 3.2). Measures of the performance of the Communication Plan implementation in 2019-20 include:
  - > Mailing list of stakeholders increased from 400 to 420 individuals/organisations during the year
  - > Hits on the REC website averaged 140 per month
  - > Four editions of the REC newsletter were produced and distributed electronically to stakeholders during the year as planned
- Actively continuing the REC Facebook and Twitter sites during 2019-20 (Action 3.2). The Facebook site has 69 likes (up from 60 in June 2019) and the Twitter site has 167 followers (up from 160 in June 2019).
- Responding to numerous stakeholder enquiries via the REC Secretariat (Action 1.2).
- Promoting linear reserve environmental management initiatives through the NSW Landcare Gateway (Action 3.2). The REC page is found at <http://www.landcare.nsw.gov.au/groups/nsw-roadside-environment-committee>.

The REC carried out a range of other activities in 2019-20 related to the Strategic Plan. The activities included:

- Discussing and sharing ways to manage linear reserve environments after the devastating 2019-20 bushfires. This included the post-fire management of hazardous trees.
- Receiving a presentation on the Cumberland Plain Conservation Plan by DPIE
- Receiving a presentation on ARTC environmental management
- Reviewing the 2016-19 Strategic Plan to prepare the 2020-23 REC Strategic Plan
- Holding interagency sharing sessions to improve linear reserve environmental management practices across NSW.

## Meetings

The REC met three times during 2019-20. The November 2019 meeting was held at Sydney ARTC office and February 2020 meeting held at the Chatswood Transport for NSW office.

Due to COVID-19 pandemic restrictions, the May 2020 was a virtual meeting using Microsoft Teams.
