AHF Transforming Places Through Heritage Programme - Project Viability Grants

Grants are available for charities and social enterprises in England to fund early viability and feasibility work for projects that will create alternative uses for redundant or underused, community-owned historic buildings in town centres.

The funding is intended for non-profit organisations to support the development of projects that have the potential to bring new life to high streets by creating alternative uses for redundant or underused historic buildings in town centres. Funding can be used for individual heritage buildings in, or transferring to, community ownership or that of charitable/social enterprise organisations.

The programme offers five funding strands:

- Project Viability Grants: up to £15,000, for early viability and feasibility work.
- **Project Development Grants:** up to £100,000, for capital project development costs (covered separately).
- **Crowdfunding Challenge Grants:** up to £25,000, to match fund crowdfunding campaigns (covered separately).
- **Transformational Project Grants:** up to £350,000, for transformational capital projects (covered separately).
- **Community Shares Booster Grants:** development grants up to £10,000 and equity investments up to £100,000 for Community Benefit Societies and Cooperatives. This grant programme is being managed by Co-Operatives UK on behalf of AHF (covered separately).

How To Apply

Applications can be submitted at any time.

Applicants are advised to initially complete the enquiry form on the AHF website to establish eligibility. An online application form is also available.

Grants are available for churches of all denominations and Christian charities in the UK and Ireland that are repairing, restoring, protecting and improving church buildings, cathedrals and places of Christian workshops, and helping the most vulnerable by tackling pressing social issues, including homelessness, poverty, climate change and cultural cohesion.

The Trust's mission is to equip and empower Christian organisations to have a positive and transformative impact on lives and communities.

Grants are intended to:

- Support the repair, restoration, protection and improvement of church buildings, cathedrals and other places of Christian worship, especially where those changes support wider community use..
- Equip Christian charities and churches to help the most vulnerable and tackle social issues, including homelessness, poverty, climate change and cultural cohesion.

Most of the grants awarded are between £1,000 and £15,000 for projects with a total cost of up to £1 million. Larger grants are available for projects costing over £1 million.

Applications can be submitted at any time.

Every application is reviewed by the Trustees and a decision communicated within three to six months.

Allen Lane Foundation

Grants are available to small registered charities, voluntary groups and charitable organisations in the UK for work that makes a difference to people's lives as opposed to simply alleviating the symptoms or current problems and should aim to reduce isolation, stigma and discrimination.

The Foundation makes grants to voluntary not-for-profit organisations in the UK for work which benefits groups of people who are under-represented in UK society.

Overall, the Foundation wishes to fund work which:

- Will make a lasting difference to people's lives rather than simply alleviating the symptoms or current problems.
- Is aimed at reducing isolation, stigma and discrimination.
- Encourages or enables unpopular groups to share in the life of the whole community.

The aim of the Social Cohension Programme is to:

- Proactively work towards building better community cohesion and trust, and encouraging respect and understanding in the local area
- Proactively promote the inclusion of marginalised groups and individuals in the life of the local community
- Fund work which breaks down barriers and tensions in the local community thereby reducing feelings of division and "them and us".

Applications will be particularly encouraged from areas of high deprivation but not exclusively. The Foundation is keen to support communities come up with their own solutions to local issues of division. It is open to supporting actions which are new or may have been tried before or are on-going, however, the work must have lasting benefits for those people the projects are aimed at.

The Foundation typically makes around 150 grants in a year with a total value of between £750,000 and £800,000.

The Foundation makes single grants, or grants split over two or three years.

One-off grants of between £500 and £15,000 are available. The average grant is between £5,000 and £6,000.

Grants repeated for more than one year vary from around £500 per annum up to £5,000 per annum, for a maximum of three years.

How To Apply

Applications can be made at any time and are considered three times a year, generally in February, June and October. Processing an application and making a grant usually takes between two and six months. Groups should apply as soon as they are ready as applications are processed 'all the time'.

Applications received from mid August 2021 until the beginning of December will be considered in the round leading up to the February 2022 meeting.

Applications to the Social Cohesion Programme are now paused until at least the summer of 2022 as the Trustees are concerned about the level of need across all of the Foundation's main funding programmes.

The Foundation has an online application system. The first step is to go through the online eligibility quiz. Those who are eligible will be directed to the application form.

Asda Foundation - Bringing Communities Back Together

Grants are available to local groups to reunite communities, celebrate togetherness and support groups as coronavirus restrictions are easing.

Registered charities, community groups, voluntary organisations and other not-for-profit organisations in the UK can apply for support with initiatives that will make a real long-term difference, benefiting the wider community.

In light of easing of coronavirus restrictions, the new scheme Bringing Communities Back Together aims to support local groups by providing two tranches of funding (Phase 1 and Phase 2), aimed at supporting a celebration event or enabling activities and services to get back on track after the disruption of the pandemic.

There are now four funding streams available:

- **Celebration Event** eg welcome back party, community celebration.
- **Getting Activities Back on Track** eg gardening clubs, supporting groups and recreational activities, lunch clubs.
- **Combination (of the above)** for those wanting to apply for both celebration event and getting activities back on track.
- **Essential Support** for groups who provide help for the immediate needs of disadvantaged local people.

Grants between £250 and £1,000 are available.

Funding includes the following allowances for a Celebration Event: up to £50 for decorations; a maximum of £12.50 for a meal per person; entertainment up to £125 per application.

How To Apply

The closing date for Phase 2 applications to be submitted to the Community Champion is 1 November 2021. However, if funds are depleted before the closing date, the fund will close early. **Applicants are advised to check the website to confirm closing dates.**

Application forms can be obtained from Asda Community Champions, who are based in local Asda stores. Applicants can use the store locator link on the Foundation website to get in touch with their local store and speak to their Community Champion about their project proposal.

Application forms can be obtained from Asda Community Champions, who are based in local Asda stores. There are two different application forms, one for groups who are government entity organisations and another for groups who are non-government entities. (Guidance notes on completing these forms are available on the Asda Foundation website.)

All applications must be made via the applicant's local Asda Community Champion; applications made directly by organisations will **not** be accepted by the Foundation.

Decisions will be made within six weeks of application receipt from a Community Champion.

Bernard Sunley Foundation

One-off capital grants are available to registered charities in England and Wales, as well as those with 'accepted' and 'exempt' status, for projects in the areas of community, education, health and social welfare.

The aim of the foundation is to help raise the quality of life in England and Wales, particularly for the young, disadvantaged and older people.

Although applicants may specify how much funding they need, the Trustees decide the level of grant to award based on the information contained within the application.

The minimum grant available is £1,000.

The majority (roughly 80%) of grants awarded are under £5,000. Grants exceeding £25,000 are exceptional and are typically awarded to major capital projects.

Grants are usually paid as single payments in a one-year period but, if considered particularly beneficial to the project, they may be extended over three years.

How To Apply

There are no formal application deadlines. Applications are accepted throughout the year and are reviewed in order of receipt.

Projects with budgets of £50,000 upwards should apply at least six months before their project start date.

An online application form is available to complete at the Bernard Sunley Foundation website.

Note: The Foundation receives more than 100 applications each month and does not have the resources to fund all eligible projects.

Biffa Award - Community Buildings

Grants are available for not-for-profit organisations to provide and improve community buildings that are located within the vicinity of a Biffa operation in order to 'act as mechanisms' for community involvement.

The Biffa Award Community Buildings theme provides grants to improve community buildings such as village halls, community centres and church halls within five miles of a significant Biffa operation or within 10 miles of an active Biffa Landfill site with the aim of encouraging and enhancing community involvement.

Grants of between £10,000 and £75,000 are available.

The total cost of the project must be less than £200,000, inclusive of VAT.

How To Apply

Submissions of Expression of Interest are accepted on a rolling basis. The Board meet four times a year to decide which projects to fund. Applications will go to the next available meeting so there are no restrictions on when to apply. However, groups may wait for up to six months to hear the outcome of their application.

Biffa Award - Recreation

Grants are available for not-for-profit organisations for projects that will benefit people in their spare time in communities located within the vicinity of a Biffa operation.

The Biffa Award Recreation theme provides grants to support projects that will benefit people within their free time who are living in communities within five miles of a significant Biffa Group Ltd operation or within 10 miles of an active Biffa Landfill site in England or Northern Ireland.

Grants of £10,000 to £75,000 are available.

The total cost of the project must be less than £200,000 including VAT.

Charles Hayward Foundation

Grants are available to UK registered charities for projects in the following categories: Heritage and Conservation; Social and Criminal Justice; Overseas; and Older People.

The Foundation places emphasis on funding projects that are developmental or innovative, and it is keen to support activities that would not otherwise happen. The Foundation prefers to fund projects in early stages that provide early intervention to society's problems.

The Foundation will make grants in the following areas:

- Heritage and Conservation.
- Social and Criminal Justice.
- Overseas.
- · Older People.

The Foundation offers the following:

- Small grants of up to £7,000.
- Main grants for Social & Criminal Justice for £15,000 to £25,000 per annum (for one to three years) are considered. Up to £25,000 may be available for a pilot project, if it addresses complex problems in an innovative way and may lead to replication if proven effective. One-off Heritage & Conservations projects will be awarded up to £50,000.
- Overseas grants of up to £15,000 for one-off projects.

How To Apply

Applications to the **Small Grant Programme** may be submitted any time and are considered every two to three months.

Applications to the **Main Grant Programme** is a two stage grant process as follows:

- Stage 1: A Grant Committee meets on a quarterly basis (usually usually February, May, September and November). The Committee's role is to forward applications to stage 2.
- Stage 2: Applications recommended by the Grant Committee are considered at one of the Trustees' meetings which take place on a quarterly basis and are usually held in: February; April; July; and October.

For the Main Grants Programme, there is no application form. Applicants should read the guidelines before starting the application process. Initial applications should be made in writing to the Administrator and include the following:

- Name and location of organisation.

- Description of organisation.
- Description of project.
- Project aims.
- Project cost.
- Funds already raised and pledged.
- Outstanding shortfall.
- Project timetable.

Comic Relief Community Fund for England NEW

Grants are available to support local not-for-profit groups in England to drive change in their communities.

Funding is intended to support community-led organisations to deliver change by drawing on the 'lived experiences' of people who have experienced the issues being tackled. These issues should align with one of Comic Relief's four strategic themes:

- Children Survive and Thrive ensuring every child has the best start in life.
- Fighting for Gender Justice tackling gender-based violence, inequality and exploitation.
- A Safe Place to Be supporting those who have been displaced to access secure housing and feel settled in their new homes.
- Mental Health Matters helping people with poor mental health to access appropriate support.

Grants of up to a maximum of £10,000 are available with:

- Capacity Building grants of up to £1,000 to be spent on activities to strengthen operations and governance. (All applications must include this grant).
- Project Delivery grants of up to £9,000 to deliver projects that fit with the programme's strategic themes.

How To Apply

This is a three-year fund with three application rounds:

- Round 1 is currently open with a deadline of 29 November 2021. Panel meetings are expected in February
- Round 2 will open in March 2022 and close in June 2022. Panel meetings are expected in September 2022.
- Round 3 will open in October 2022 and close in January 2023. Panel meetings are expected in March 2023.

Please note the fund may close earlier than the deadline if sufficient applications are received before the date.

The first step in the application process is to complete an online Eligibility Checker. Eligible groups will then be given a link to the online application form.

Esmee Fairbairn Foundation - Grants UPDATED

Grants are available to organisations doing legally charitable work in the UK that focuses on the Foundation's funding priorities of improving the natural world, securing a fairer future, and strengthening the bonds in communities in the UK.

The funding is intended for projects with the following aims:

Faith New Deal Pilot Fund NEW

Grants are available to faith-based organisations for innovative projects which strengthen engagement between local and national government and faith groups as they tackle social issues, including those arising from the impact of COVID-19 in the recovery efforts of communities in England.

The Ministry of Housing, Communities and Local Government has launched the new £1 million Faith New Deal Pilot Fund as a means to focus on strengthening engagement between national government, local government and faith groups.

The competitive grants programme has been set up in recognition of the role faith-based organisations play in the resilience of their communities and the importance of local faith groups working collaboratively to respond to societal issues, particularly during the COVID-19 pandemic.

The pilot fund has been designed to support faith-based organisations build on and expand the good work being carried out locally and to demonstrate the important role they play in tackling and responding to social challenges as the country moves into post COVID recovery and rebuilding of civil society.

A total of £975,000 is being made available which will be distributed as:

- Grants of up to £125,000.
- Grants of up to £200,000 for innovative projects to be delivered by new or existing partnerships. This must include a community need that seeks to support COVID-19 recovery and solve a local problem.

The fund will provide up to a maximum of 50% of the project's delivery costs.

How To Apply

The deadline for applications is 23:50 on Thursday, 7 October 2021. Decisions will be made in October 2021.

Listed Places of Worship Grant Scheme

The minimum value of invoices (excluding VAT) for any one claim to the scheme is £1,000. An application may comprise a number of smaller invoices, but each claim must apply to works that are eligible under the scheme and together generate combined invoice values of no less than £1,000 excluding VAT.

In addition, to allow places of worship undertaking smaller works to benefit from the scheme, each listed place of worship **will also be allowed to submit one claim** with a value of between £500 and £1,000 (excluding the VAT paid) in any 12 month period.

Claimants are expected to ensure that that all other eligible VAT reliefs are sought before seeking a grant under the scheme.

Grants are available to smaller community-led groups that support people at the margins of society in the UK, encouraging independence, inclusion and integration.

The Trust funds a wide range of organisations working to support positive change in people's lives and in their communities around the UK. It does not have any specific funding programmes to advance any particular agenda, but it is keen to work with organisations that have a real understanding of the challenges facing the communities they support and a clear sense of the difference they seek to make through their work.

There is no maximum or minimum level of grant, although it is unusual for a grant of less than £10,000 to be made. Grants are usually for one, two or three years.

Funding is sometimes available over a longer period, usually by making a further grant following on from the original one.

Advice and development support for organisations is also available from the Trust.

The Trust currently funds around one in eight applications.

How To Apply

Applications can be made at any time and are assessed on a rolling basis.

Applications should be made online. There is a two-stage process:

- Applicants should create an account, then fill in a brief online form and upload their cover letter, answers to the five application questions (see funding guidelines) and a copy of their latest annual accounts.
- Those who are successful at this initial stage will go through to the second stage, which involves an indepth conversation, via phone or Zoom with one of the Trust's grant managers.

Veolia Environmental Trust

Grants for constituted, not-for-profit organisations and local authorities for projects that make improvements to community facilities and the natural environment that are located near a qualifying Veolia site in England.

The Trust currently offers three grant schemes:

- Community Grants are for constituted, not-for-profit organisations and local authorities to create or improve community buildings or outside spaces for the benefit of the community.
- Environmental Improvement Grants are for Environmental Bodies that are enrolled with ENTRUST, the regulator of The Landfill Communities Fund, and are a registered charity. Grants are available to enable landscape scale improvement projects such as habitat creation/management, and/or species protection.
- Habitat and Biodiversity Grants are for constituted, not-for-profit organisations that are enrolled with ENTRUST to support structural improvements to a single habitat, such as a waterway, woodland, or nature reserve.

Three different grants are available:

Community grants of between £10,000 and £75,000 for:

- Projects with a total cost of no more than £250,000 (including VAT and professional costs).
- Projects where the 10% Contributing Third Party (CTP) payment has been secured.

Habitat and Biodiversity Grants of between £10,000 and £75,000 for:

- Projects with a total cost of no more than £250,000 (including VAT and professional costs).
- Projects where the 10% Contributing Third Party (CTP) payment has been secured.

Environmental Improvement Grants start at £75,000. There is no upper limit. CTP payment is applicable.

Grants will be paid by BACS transfer in three separate payments.

How To Apply

There are four funding rounds each year. It is important that groups apply at the right time, as only one grant application may be submitted per project site, in a 12-month period.

The next application windows are:

- 12 August 2021 to 30 September 2021 (12 noon) with a decision by 7 December 2021.
- 11 November 2021 to 6 January 2022 (12 noon) with a decision by 8 March 2022.

Applicants should refer to the new guidance notes/criteria which are available to download from the Trust's website.

Please note the criteria is reviewed quarterly. Applicants need to read the criteria that is current at the time that they are making an application to ensure their grant request remains eligible.

Community grant applications will be reviewed against the following:

- How much the project will benefit the general public
- What evidence has been provided that the project is needed
- The opportunities for volunteering and community involvement that will be created or maintained by the project.
- The effect the project will have on the environment.
- The financial viability and sustainability of the project.
- Index of Multiple Deprivation

Limited funding is available each round and grants are awarded to the projects which most closely match the Trust's funding priorities.

Environmental Improvement Grant applicants will need to submit a proposal. Full details can be found in the guidance notes on the Trust's website. The Trust will contact applicants within five days to discuss the proposal and the next steps.

It is especially interested in helping groups that are starting up and need a little seed money to help them get going.

All the community projects the Trust supports have, as a common theme, the empowerment of ordinary non-professional people.

Funding is at the discretion of the Trustees. However, as a a guide, grants are normally given to projects where an initial £125 to £2,500 will make a real difference.

How To Apply

Applications may be submitted at any time, preferrably by email.

To apply to the Trust, applicants are required to send the following information below in the order requested:

- Contact name, address (including postcode), telephone number and email.
- Name and address of the project the applicant is applying on behalf of, plus its telephone number and email.
- Name and address of a UK charity which is willing to accept a grant on the applicant's behalf, plus the name of a contact the Trust can talk to at that charity.
- Account name, bank sort code and account number of the charity's account into which the applicant would like a grant to be paid.
- Details of the project. Who does it help? How big is it? Is it new, or already established?
- How much money is being requested from the Trust?
- What would the money be spent on? Applicants should give a rough breakdown and overall budget.
- How else has the applicant tried to raise funds and how successful has this been?
- Has the applicant ever received a grant from the Trust before?

Weinstock Fund

Grants are available for smaller UK registered charities to support a wide range of charitable causes in the UK.

The trust is particularly interested in supporting charitable causes in the arts, community groups and projects, cultural and environmental causes, disability groups and charities supporting people with disabilities, educational projects, welfare causes to include hardship alleviation, and medical charities encompassing treatment, care and support.

Funding is at the discretion of the trustees. Typically grants range from £1,000 to £5,000.

Last year, 152 grants, totalling around £672,000, were awarded to the charitable sector.

Multi-year grants up to a maximum of three years are considered.

How To Apply

The guidance notes and online application form are available on the Weinstock Fund website.

There are no application deadlines as the Trustees consider batches of applications on a rolling basis. The trustees meet three to four times a year and will notify applicants of the result of their funding request though it can several months before a group is informed of a decision.

Groups that are requesting funding for a time-dependent project should submit their application at least six months before the start of their project.
