STUDENT TUITION RECOVERY FUND

The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. Unless relieved of the obligation to do so, you must pay the state-imposed assessment for the STRF, or it must be paid on your behalf if all of the following applies to you:

1. You are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition either by cash, guaranteed student loans, or personal loans, and
2. Your total charges are not paid by any third-party payer such as an employer, government program or other payer unless you have a separate agreement to repay the third party.

You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if either of the following applies:

1. You are not a California resident, or are not enrolled in a residency program, or
2. Your total charges are paid by a third party, such as an employer, government program or other payer, and you have no separate agreement to repay the third party.

You may be eligible for STRF if you are a California resident or are enrolled in a residency program, prepaid tuition, paid the STRF assessment, and suffered an economic loss as a result of any of the following:

1. The school closed before the course of instruction was completed.
2. The school's failure to pay refunds or charges on behalf of a student to a third party for license fees or any other purpose, or to provide equipment or materials for which a charge was collected within 180 days before the closure of the school.
3. The school's failure to pay or reimburse loan proceeds under a federally guaranteed student loan program as required by law or to pay or reimburse proceeds received by the school prior to closure in excess of tuition and other costs.
4. There was a material failure to comply with the Act or this Division within 30 days before the school closed or, if the material failure began earlier than 30 days prior to closure, the period determined by the Bureau.
5. An inability after diligent efforts to prosecute, prove, and collect on a judgment against the institution for a violation of the Act.

NOTICE CONCERNING TRANSFERABILITY OF CREDITS AND CREDENTIALS EARNED AT OUR INSTITUTION

The transferability of credits you earn at Marston Polygraph Academy is at the complete discretion of an institution to which you may seek to transfer. Acceptance of the certificate you earn in the Polygraph Examiner program is also at the complete discretion of the institution to which you may seek to transfer. If the certificate that you earn at this institution is not accepted at the institution to which you seek to transfer, you may be required to repeat some or all of your courses work at that institution. For this reason you should make certain that your attendance at this institution will meet your educational goals. This may include contacting an institution to which you may seek to transfer after attending Marston Polygraph Academy to determine if the certificate you earn will transfer.

Please note that English is the only language in which recruitment is conducted.

STUDENTS RIGHT TO CANCEL

You have the right to cancel the enrollment agreement you sign for a course of instruction including any equipment, such as books, materials, and supplies, or any other goods and services included in the agreement, and obtain a full refund of all charges paid through attendance at the first class session, or the seventh day after enrollment, whichever is later. This is the date by which a student must exercise his or her right to cancel or withdraw this session:

Cancellation occurs when you give written notice of cancellation to the director at the institution's address and is considered effective no later than the date received by the institution. You may deliver a cancellation by U.S. mail or in person only. The notice, if mailed is effective by postmark date. This notice need not take any specific form; it needs only to state that you wish to cancel this agreement. If you cancel this agreement, the academy will refund any money that you paid, less any deductions for Academy property or equipment not timely returned in good condition within 30 days after receipt of the notice.

WITHDRAWAL & REFUND RIGHTS:

You have the right to withdraw from the academy at any time. If you withdraw from the course after the cancellation period described above, the academy will remit a refund less a registration fee of \$100.00 within 45 days following your withdrawal. The institutional refund policy for student who has completed 60 percent or less of the course of instruction shall be a prorated refund. You are obligated to pay only for the educational services rendered. The amount owed equals the hourly charge for the program multiplied by the number of hours of instruction for which you were scheduled to attend prior to withdrawal. If the amount you have paid is more than the amount you owe, then a refund will be made within 45 days of your withdrawal date. If the amount that you owe is more than the amount you paid, then you will have to make arrangements to pay it.

Enrollment: Is defined as scheduled hours of attendance, that portion of the course scheduled to be completed between the actual starting date and the date of the student's last day of physical attendance in the academy.

Language: The program is provided in English only. Those for whom English is not a primary language may contact the director with questions regarding the program, enrollment agreement, disclosures and statements.

Location of training: The location of the training will be at Marston Polygraph Academy, 1845 Business Center Dr., Ste 210, San Bernardino, CA. 92408. The Marston Polygraph Academy provides no in-resident housing.

Tutoring: Extra help is available from the Marston instructors when requested at no additional charge. Additional work may be assigned.

Training and equipment: Except for a laptop computer with an external (Logitech or similar) camera, all equipment and supplies are provided for student use during Marston Polygraph Academy class sessions.

Other charges paid to an entity: There is no licensing law in the State of California and no charge by any other entity to be a polygraph examiner in the state. However, graduates are encouraged to join polygraph organizations that provide continuing education required for the profession.

HYPOTHETICAL EXAMPLE: You are obligated to pay only for educational services rendered and for unreturned books or equipment.

- a) Deduct a registration fee (\$100.00) from the total tuition charge.
- b) Divide this figure by the number of days in the program.
- c) The quotient is the daily charge for the program.
- d) The amount owed by you for purposes of calculating a refund is derived by multiplying the total days attended by the daily charge for instruction.
- e) The refund would be any amount in excess of the figure derived in (D) that was paid by you.
- f) The refund amount shall be adjusted for equipment, if applicable.

If you receive federal student financial aid funds, you are entitled to a refund of moneys not paid from federal student financial aid program funds. If you obtain a loan to pay for your educational program, you will have the responsibility to repay the full amount of the loan plus interest, less the amount of any refund. If the student is eligible for a loan guaranteed by the federal or state government and the student defaults on the loan, both of the following may occur:

- (1) The federal or state government or a loan guarantee agency may take action against the student, including applying any income tax refund to which the person is entitled to reduce the balance owed on the loan.
- (2) You may not be eligible for any other federal student financial aid at another institution or other government assistance until the loan is repaid.

Prior to signing this enrollment agreement, you must be given a catalog or brochure and a School Performance Fact Sheet, which you are encouraged to review prior to signing this agreement. These documents contain important policies and performance data for this institution. This institution is required to have you sign and date the information included in the School Performance Fact Sheet relating to completion rates, placement rates, license examination passage rates, salaries or wages, and the most recent three-year cohort default rate, if applicable, prior to signing this agreement.
