NARRATIVE:

On 9/28/11 at about 2128 hours I took a complaint of threatening phone calls over the phone at the South Substation. The victim said he just wanted to make the report over the phone; no arrest was made. Offender was told not to call or go to the property.

On 9/28/11 at about 2128 hours I, Dep. Presley, spoke to Eric Hatfield over the phone. Eric said a customer of his called his business and spoke to his secretary, Amy Senn. Eric said the customer who called was Vicki Pendleton. Eric told me Vicki was upset about something and was complaining to his secretary. He said she called and hung the phone up. Eric said the secretary attempted to call back twice to see what the problem was and did not get an answer. Eric told me Vicki called again and he spoke to her in an attempt to resolve the issue. He said while he was talking to her, she told him he would be sorry he ever met them. He said she also told him they would destroy him and his property. Eric told me he didn't feel the threat would be carried out but wanted a report in case something did happen. Eric said he believes the issue was over a car he sold to the Pendleton's. He said the car was purchased at auction, sold to the Pendleton's who in turn traded the car in. Eric said the car was purchased again by his business at auction and is currently for sale. He said he thinks the Pendleton's saw the vehicle on the website (www.hatfieldwholesale.com). Eric said he did not want the Pendleton's to call or come to his property from now on.

I went to 3115 Lee Avenue to contact Vicki about the situation. Vicki and her husband, Randal Pendleton, came to the door. Before I could tell them the reason I was there, Vicki said Hatfield called their house three times. She said the matter with Hatfield was a civil issue. She said she had already spoke to my supervisor about it. I asked for their I.D. and they refused to give it to me. Randal came outside and showed me a picture of a silver Volkswagon Beetle. He said they bought the car from Hatfield and traded it for another vehicle. He said nothing worked in the car and they were going to take him to court over it. I asked for their I.D.'s again and they would not give me their information. Before they slammed the door, I told them not to call Hatfield or go to his property from now on. Vicki agreed she wouldn't.

No arrest was made. Eric Hatfield said he just wanted to make a report in the event something may happen to his property.




