A motion for discovery has been filed by the defendant as provided by La.C.Cr.P. Arts. 716-723.

In accordance with the provisions of La.C.Cr.P. Arts. 724-725, the State of Louisiana requests that the Court order the defendant to disclose to the State, and to permit and authorize the State or an expert working with the State through the District Attorney to inspect, copy, examine, test scientifically, photograph, or otherwise reproduce books, papers, documents, photographs, tangible objects, buildings, places or copies of portions thereof which are within the possession, custody or control of the defendant, and which the defendant intends to use in evidence at the trial, including any results of reports or copies thereof, of physical and mental examinations and of scientific tests or experiments, made in connection with the particular case, that are in possession, custody, control or knowledge of the defendant and that the defendant intends for use at the trial. If the witness preparing the report will be called as an expert, the report shall contain the witness's area of expertise, his qualifications, a list of materials upon which his conclusion is based, and his opinion and the reasons therefore. If the expert witness has not reduced his results or reports to writing, or if the expert witness's written report does not contain the information required of an expert as provided for in La.C.Cr.P Art. 725, the defendant must produce for the State a written summary containing the information required to be produced pursuant to this Article but absent from a written report, if any, including the name of the expert witness, his qualifications, a list of materials upon which his conclusion is based, and his opinion and the reason therefore.

In accordance with La.C.Cr.P Art. 725.1, the State of Louisiana requests that the Court order the defendant to disclose to the District Attorney, prior to those witnesses being swom, the name and date of birth of the witnesses to be called by the defendant in his case in chief. Furthermore, and also pursuant to La.C.Cr.P.Art.725.1, the State of Louisiana requests that the Court order the defendant to disclose to the district attorney, and permit or authorize the district attorney to inspect and copy, any written or recorded statements of any witness the defendant intends to call at trial to include any audio or audio-video recording of any oral statements or interview of a witness, and any statements a witness writes or signs.

The State of Louisiana requests that the Court order the defendant to give the District Attorney notice in the manner provided by La.C.Cr.P.Art.726 of any defense based upon mental condition of the defendant.

The State of Louisiana has responded to defendant's Motion for Discovery, same alleging the date and time of crime, and the State of Louisiana requests that the Court order the defendant to give the District Attorney written notice in the manner provided by La.C.Cr.P. Art 727 of defendant's intention to offer a defense of alibi



HORTON AGAIN UNPROMPTED AND WITHOUT CONSENT. HORTON WAS "FROZEN" FOR APPROXIMATELY 5-10 SECONDS DUE TO BEING "TAKEN ABACK" AND HORTON WAS SURPRISED BY BLANCO'S VISIT BUT ALLOWED HIM TO ENTER THE RESIDENCE. THE TWO SAT DOWN ON SEPARATE SIDES OF HORTON'S SECTIONAL SOFA AND "SAT IN AWKWARD SILENCE" FOR A FEW MOMENTS BEFORE HORTON LAID DOWN ON HER SIDE. AT THAT TIME THIS MORNING AT APPROXIMATELY 0815HOURS SHE HEARD A KNOCK AT THE FRONT DOOR OF HER RESIDENCE. IND THE SUSPECT, JOHN BLANCO, WHO WORKS WITH HORTON AT BROTHER'S HAIR DESIGN AND AS A DEPUTY CONSTABLE FOR CADDO ARISH. BLANCO HAS BEEN TO HORTON'S RESIDENCE ONCE IN THE PAST, TO DROPPED OFF HIS K9 FOR WHOM HORTON HAD AGREED TO

BLANCO IN THE HOME; HOWEVER SHE ONCE AGAIN "FROZE IN FEAR". AT THAT TIME BLANCO APOLOGIZED TO HORTON FOR "ACTING OUT OF BACK ENTRY OF THE GARAGE, AND THROUGH THE SIDE ENTRY OF THE HOME, UNAUTHORIZED. HORTON WAS SURPRISED WHEN SHE OBSERVED NOT ANSWER THE DOOR. 

BEFORE ME, the undersigned District Court Judge, personally came and appeared DETECTIVE DE'ANDRE BELLE, Shreveport Police Department/ Sex Crimes Unit, who after being fully sworn, deposed and requested that a warrant of JON BLANCO, W/M DOB 11/15/1987, 5505 Asbury Ln. Shreveport, Louisiana 71129 for the offense of:

UNAUTHORIZED ENTRY OF AN INHABITED DWELLING in violation of R.S. 14:62.3 on September 24, 2018, he intentionally entered the home of (WF, Caroline Horton DOB: 12/10/1992) thru a doggy door without authorization. A home or place of abode located at 5747 Grover Place, Shreveport, La. 71105.

Probable cause for issuance of this warrant, all of which was learned by affiant through personal investigation and the investigation of others, is as follows:

On September 24, 2018 at around 1830hrs, I was contacted Lt. Donald Vishnefski in regards to an adult female who stated she was sexually assaulted by a known male at her residence earlier today and he entered her residence without consent. I advised Lt. Vishnefski, I was enroute to his location to investigate this incident.

Upon my arrival at the scene, I contacted Officer K. Rawls, the original responding officer who advised the Comp. Caroline Horton stated her co-worker John Blanco who's also a Deputy Constable sexually assaulted her earlier today at her residence and then came back later and entered her residence without consent. Officer Rawls stated Ms. Horton has a video surveillance security system which captured Mr. Blanco pulling on her outside doors and then entering her residence without her consent.

I interviewed Caroline Horton inside her residence. The interview was digitally recorded. For more information refer to the recording. The following is a summary of that interview. Caroline

1,

Horton stated she has known John Blanco for the last couple of years because they work together at the Brothers Hair Salon located on Kings Hwy. Caroline advised this morning around 0800hrs she was awaken by John Blanco knocking on the front door of her residence with a cup of coffee in his hand. Ms. Horton said she opened the front door and John stated he was in the area and wanted to bring her a cup of coffee. Caroline stated she let Mr. Blanco into her residence and while he sat on the couch she laid down on the sofa. Ms. Horton advised while she was lying on the sofa with her back to John he put his hands underneath her shirt and touched her bare breast without consent. Caroline said she immediately froze because she couldn't believe he touched her and then she quickly got up to walk to the restroom. Ms. Horton stated once in the restroom she got in the shower and John walked into the restroom without consent. Caroline advised while in the restroom Mr. Blanco saw her naked taking a shower and said, "this water gets hot fast". Ms. Horton said she asked John to leave the restroom and then she ran into her bedroom where she got dressed for work. Caroline stated after getting dressed they both walked out of her residence and went to work. Caroline advised on this same date, she took a lunch break around 1300hrs and drove home. Ms. Horton said while she was at her residence John called her cell phone twice but she didn't answer because she didn't want to deal with him. Caroline stated about ten minutes later Mr. Blanco pulled up to her residence in his Constable Patrol unit and walked to her front door. Ms. Horton advised John knocked on the front door and pulled on the door knob. Caroline said she was looking at Mr. Blanco on her system surveillance system. Caroline stated John then walked to the back yard of her residence which is gated and he pulled on the back door knob attempting to gain entry into her residence. Ms. Horton advised John walked to the north side of her residence where he walked into her garage and entered her residence thru a doggy door without her consent. Caroline said she was hiding underneath her covers because she was afraid of him. Ms. Horton stated once inside her residence Mr. Blanco started apologizing for touching her breast earlier and said he was acting out of character. Caroline advised John told her he was going through a lot of family issues and needed someone to talk to. Ms. Horton said she told John he freaked her out by walking thru the side door of her residence without consent in which he apologized again and left her residence. Caroline stated she wanted to pursue charges against John Blanco for sexually battery and entering her residence without consent. This concluded my interview with Caroline Horton.

On this same date, Crime Scene Investigator Cpl. Robert Cerami responded to the scene where he took photos and downloaded the surveillance system on a hard drive. Cpl. Cerami later downloaded.

the surveillance video to my office computer to be viewed. I reviewed the surveillance system which showed John Blanco arriving at Carolyn Horton's residence at 0720hrs in a dark colored Nissan sedan, Ms. Horton let him into the residence through the front door and they left the residence at 0820hrs.

On this same date, the surveillance video shows John Blanco arriving at Carolyn Horton's residence at 0120hrs in a black marked Constable Patrol unit. Mr. Blanco walks up to the front door and knocks on the front door but no answers it so he walks around the rear of the residence at 0124hrs. Jon walks opens a locked gate to get to the rear of the residence and tries to gain excess to the residence by turning the knob on the back door but it was locked. When the door didn't open he went thru a side door to the garage and entered the residence without Ms. Horton's consent.

On September 26, 2018, I contacted Caitlin Wilson who works with Caroline Horton and John Blanco at Brother's Hair Salon. I conducted a phone interview with Ms. Wilson. The interview was digitally recorded. For more information refer to the recording. The following is a summary of that interview. Caitlin Wilson stated she worked with Mr. Blanco and Ms. Horton for the past 6 years at the Salon. Caitlin advised John also works for the Caddo Parish Constable's Office part time. Ms. Wilson said John has never touched her inappropriately but he flirts and jokes with Caroline all the time at work. Catlin stated Mr. Blanco always wants to know where Caroline's located because he likes her. Ms. Wilson advised John and Caroline have never been in a sexual relationship together. This concluded my interview with Catlin Wilson.

On this same date, I contacted John Blanco by phone and setup a meeting with him on September 27th at 1000hrs but he refused to show up for the appointment. I later received a call from his attorney Natalie Howell advising Mr. Blanco will not come to my office to give his side of this incident.

On October 1, 2018, Carolyn Horton contacted me and advised she had more information to give me in regards to this case. I relocated to her place of employment to interview her again. The interview was digitally recorded. For more information refer to the recording. The following is a summary of that interview. Carolyn Horton stated she always knew John Blanco had an infatuation with her but he didn't make her feel uncomfortable until recently. Ms. Horton advised about four weeks ago John Blanco started slapping her butt while they were at work and then he

would use his finger to fondle her vagina when she walked past him without consent. Carolyn said she ask him to stop and figured he would. Ms. Horton stated John also started calling her back to his station and exposing his penis to her. Carolyn advised Mr. Blanco told her it was hard for him to groom his pubic hairs because of his excess skin. Ms. Horton said when John came to her residence and fondled her breast without consent, he also attempted to rub her vagina but she stopped him and he openly rubbed her pubic hairs. Carolyn stated she has never had sex with John and has never talked about having a sexual relationship with him. This concluded my interview with Carolyn Horton.

WHEREFORE affiant prays that a warrant issue as requested.
