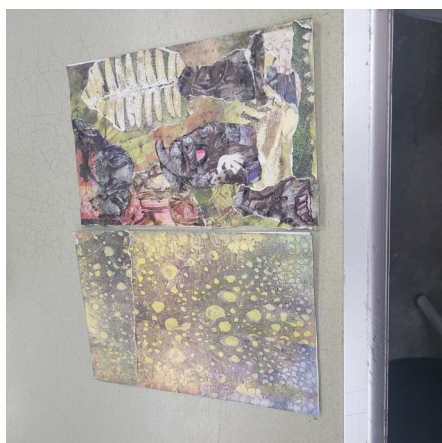
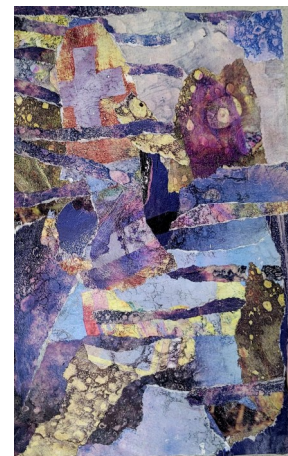

square until noon.

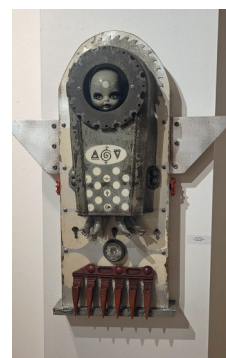
Non-member guests are welcome—for a \$5 fee. No fee for mem-
