1. Open to all Bowlers. Top 5 team positions paid, amount of pay out is determined by number of team entries.
2. Bowler's tournament average: 180 men / 140 women. Handicap: 90% from 850.
4. USBC highest average at the end of 2022-2023. season will be used. Must have 12 games. Bowlers not having a average must use last year's highest USBC average of 12 games or more. If you have no average from last year you may bowl using the highest average of 12 games or more from this year, all others must use 180 for men and 140 for women. Must have proof of average.
5. All teams will consist of 5 people (men, women, or mixed).
6. Check in time is 12:00 – 12:45 pm. No entry fee will be returned. **All entries must be submitted/paid by April 20, 2024.**
7. Bowl 3 games on same pair of lanes.
8. All prize monies involving ties will be split.
9. All interpretation of rules will be made by the tournament committee. We reserve the right to re-rate any average.
10. All rules not covered by the tournament rules will be covered by USBC. All disputes or protests must be brought to the attention of the tournament committee.
