

**GROVELAND ELECTRIC LIGHT DEPARTMENT
TOTAL ELECTRIC RATE T**

AVAILABILITY

Electricity is available under this schedule for all purposes and to the customers stated below in accordance with the conditions stated:

ELIGIBLE PREMISES

1. An individual residence or individual apartment.
2. Motels, hotels, apartment houses and similar installations used primarily for living quarters.
3. A church or school, including adjacent buildings, owned and operated by such church or school and used primarily for religious or educational purposes.

CONDITIONS OF SERVICE

1. The customer's requirements for energy for all purposes must be supplied under this rate.
2. Electricity must be the only source of energy at the premises.
 - 2a. A wood fueled fireplace used for aesthetics, not as a main source of heating, is allowed.
3. All electricity will be measured by a single meter.
4. All space heating equipment must be permanently installed.
5. This rate is not available to temporary, intermittent, periodic or seasonal customers.
6. This rate is not available for resale.

**TOTAL ELECTRIC RATE T
(Continued)**

7. **This rate shall permanently close to all new customers as of July 1, 2018.** Any customer not currently receiving service under this rate on July 1, 2018 shall be ineligible for service under this rate regardless of whether said customer would otherwise meet the conditions necessary to qualify for the rate.

Only those Customers then receiving service under this rate as of July 1, 2018 shall be “grandfathered” and eligible to continue receiving service, until such time as they are no longer the Customers of record at the premises served.

8. As a condition of receiving, or continuing to receive service under this rate schedule, Customers **shall** permit the Department to make an inspection of the premises upon reasonable notice as necessary to confirm compliance with the foregoing requirements.

RATE – APPLIED MONTHLY

The rate shall be the sum of the Customer Charge and the Energy Charge as defined below:

Customer Charge:		\$8.70
Energy Charge:	First 500 kWh	\$.0739 per kWh
	Over 500 kWh	\$.0627 per kWh

DISCOUNT

A discount of ten (10) percent will be allowed if payment is received on or before the fifteenth (15th) of the month in which the bill is rendered, provided all previous bills have been paid and the account is up to date. No discount is allowed on the Minimum Charge or Purchased Power Adjustment Charge.

**TOTAL ELECTRIC RATE T
(Continued)**

MINIMUM CHARGE

The Minimum Charge is the Customer Charge.

PURCHASED POWER ADJUSTMENT

The amount determined under the preceding provisions will be adjusted in accordance with the Department's Purchase Power Charge, M.D.P.U. No. 62.

INSTALLATION OF EQUIPMENT

All water heating and space heating equipment and the installation of such equipment shall comply with the requirements of the Department.

RULES AND REGULATIONS

The Department's Rules and Regulations in effect from time to time, where not in conflict with specific provisions hereof, are hereby made a part of this rate schedule.
