### AVAILABILITY

Available for commercial and industrial purposes and other purposes requiring comparable service where all charges are based on a demand of 10 kilowatts or more, in premises described in the application for service. Not available in any portion of the energy used for domestic purposes in residential premises. Not available for auxiliary service. Not available for welding without a supplementary agreement.

#### RATE - APPLIED MONTHLY

The rate shall be the sum of the Customer Charge, Demand charge and the Energy Charge as identified below:

### DISCOUNT

A discount of 10 percent will be allowed if payment is received on or before the fifteenth of the month in which the bill is rendered, provided all previous bills have been paid. No discount is allowed on minimum charge or fuel adjustment.

#### MINIMUM CHARGE

The minimum charge will be the Customer Charge.

#### PURCHASED POWER ADJUSTMENT

The amount determined under the preceding provisions will be adjusted in accordance with the Department's Purchased Power Adjustment Charge, MDPU#62

# LARGE COMMERCIAL AND INDUSTRIAL - RATE C (Continued)

## DETERMINATION OF DEMAND

For loads of 50 kilowatts or more, the maximum 15 minute demand (either kilowatts or kilovolt-amperes) will be measured during the monthly billing period. In the case of rapidly fluctuating loads the demand may be established by less than 15 minute periods, or by a consideration of instantaneous peaks or connected loads.

Demands of smaller loads may be established temporality from a consideration of individual circumstances such as connected load or metered kilowatt-hours.

Under ordinary circumstances a use of 2,500 kilowatt-hours a month for four consecutive months in a year will be held as having established a demand of 10 kilowatts.

Demands established prior to the filing of this rate will be considered as having been established under this rate.

### BILLING DEMAND

The billing demand will be the demand established as described above, but not less than 80 percent of the highest demand established during the preceding eleven months and in no case less than 10 kilowatts.

## HIGH TENSION METERING CREDIT

\* 3 acets - Esty's Severpumpon Main St Clesterton - Bldg B

When energy is measured at a voltage of 2400 volts or higher, credit will be given to the extent of 2 percent of the sum of the net, or discounted, Demand charge and the net, or discounted, Energy charge, not including fuel adjustment.

## TRANSFORMER OWNERSHIP CREDIT \*

Customers may be expected to supply their own transformers for loads of 100 kilowatts or more.

If a customer furnishes, installs, owns and maintains at his own expense the protective devices, transformers and such other equipment as the Manager may specify for his service, the energy will be measured at line voltage, and an additional credit will be applied to the amount of 15 cents per kilowatt of billing demand.

## TERM OF CONTRACT

No term requirement except the minimum of one year.

## TERMS AND CONDITIONS

The general Terms and Conditions of the Department are a part of the rate schedule.
