1. The undersigned hereby applies for electric service in the Town of Groveland, MA and agree to be bound by the terms and conditions printed below and to use and pay for such service at the Electric Department's published rate for service.
2. The undersigned agrees to pay all bills within **30 days** from date of bill.
3. A minimum charge per meter, per month will be made depending upon class of service.
4. The consumer will be held responsible for all charges for electricity furnished under this agreement until the Electric Department has been notified in writing to discontinue the service and has had time to remove the meter.
5. The consumer will be held responsible for any damage to or loss of the Electric Department's property located upon his or her premises, unless occasioned by the Electric Department's negligence.
6. The Electric Department will not be responsible for any failure to supply electricity, or for interruption or reversal of the supply, if such failure, interruption or reversal is without willful defaults or neglect on its part.
7. Permission is given the Electric Department to enter the consumer's premises at all times for the purpose of inspecting and keeping in repair or removing any or all of its apparatus in connection with the supply of electricity, and, for said purpose, the consumer will request his or her landlord, if any, to permit said Electric Department to enter said premises.
8. The benefits and obligations of this agreement will commence on the day the consumer is connected to the Electric Department's service for the purpose of taking electricity hereunder, and will inure to, and be binding upon the Successors and assigns, survivors and executors or administrator (as the case may be) of the original parties hereto.
9. The consumer agrees, upon demand of the Electric Department, to deposit with it, as collateral security for the performance of the terms of this agreement, the sum of \$\_\_\_\_.00, to be returned minus any outstanding balances upon leaving the rented premises.
10. No agent has the authority to make, modify or alter this agreement or waive any of its conditions, or bind the Electric Department by making any promise not contained in this agreement.
11. The Electric Department reserves the right to discontinue service whenever the consumer has violated this agreement. The Electric Department also reserves the right to shut off the supply of electricity for repairs or want of supply.
