The Menoken Water District Board of Directors meets on the second Tuesday of every month at the district office at 7:00 p.m. to review monthly financial, operation reports and conduct any other business brought before the board. The meetings are open to all district electors/ customers. Meeting notices are posted in the entrance of the district office.

The District Board of Directors are not paid positions, Directors are reimbursed for travel expense to meetings.

The Menoken Water District is a title 32 quasi-municipal special district of the state of Colorado. The District is operated as an Enterprise fund. By law, enterprise funds cannot be supported by tax revenues but rather by service charges and fees. The District must operate as a stand-alone business and generate the revenues necessary to provide service. The District annual Budget and rates are posted on the web site address below or copies can be provided by the office.

The next District Board of Directors regular election will be held on Tuesday May 6<sup>th</sup>, 2027.

Any person who desires to be a candidate for the office of the district board shall file a self-nomination and acceptance form signed by the candidate and by a registered elector of the district as a witness to the signature of the candidate. On the date of signing, the candidate shall be an eligible elector of the district in which the candidate is running for office. The self-nomination and acceptance form shall be filed with the designated election official at the district office no later than February 28<sup>th</sup>, 2027 at 4:00 p.m., who will verify and process the form. Self-nomination forms may be obtained at the district office. An application to request permanent mail-in voter status can be obtained from the Montrose County clerk and recorder, or the office of the secretary of state, and can be returned to the Montrose County clerk.
