AMENDMENT OF BYLAWS OF

a non-profit Florida corporation

SUNFLOWER CONDOMINIUM ASSOCIATION, INC., a non-profit Florida corporation, makes the following Amendment to its Bylaws:

1. The purpose of the Amendment is to amend the Bylaws of SUNFLOWER CONDOMINIUM ASSOCIATION, INC., a non-profit Florida corporation and its Amendments thereto, filed in Official Records Book 2614 Pages 1467-1473 of the Public Records of Palm Beach County, Florida.

2. That in accordance with the SUNFLOWER CONDOMINIUM ASSOCIATION, INC. Bylaws Paragraph 59 entitled "AMENDMENT OF BYLAWS" the membership voted to amend Paragraph 4 entitled "MEMBERS' MEETING" as follows:

The annual meeting of members shall be held as set forth in Article VIII of the Articles of Incorporation, and subsequent annual meetings shall be held on the second Wednesday of May in each succeeding year unless such date falls on a legal holiday, in which event, it shall be held on the following day at 7:00 p.m. At such meetings, the members shall elect, by majority vote, such member or members of the Board of Directors as they shall be entitled to elect in accordance with the Articles of Incorporation, and transact such other business as may be properly brought before the meeting.

3. That except as previously amended and as herein amended, the Bylaws of SUNFLOWER CONDOMINIUM ASSOCIATION, INC., a non-profit Florida corporation, as recorded in Official Records Book 2614 Pages 1461-1473 of the Public Records of Palm Beach County, Florida shall remain in full force and effect.

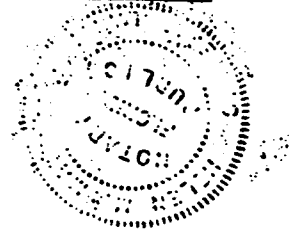
