**NINTH CERTIFICATE OF AMENDMENT TO THE BY-LAWS
OF SUNFLOWER CONDOMINIUM ASSOCIATION, INC.**

THE UNDERSIGNED certify that By-Law 4 of the By-Laws of Sunflower Condominium Association, Inc., which By-Laws are recorded as an exhibit to the Declaration of Condominium of Sunflower Condominium recorded in Official Records Book 2614 at page 1404 of the Public Records of Palm Beach County, has been amended as follows:

The first annual meeting of members shall be held as set forth in Article VIII of the Articles of Incorporation, and subsequent annual meeting meetings shall be held ~~on the second Monday of February of each and every year~~ at such time and place as the Board of Directors may determine; provided however, that each annual meeting shall take place within 13 months of the previous annual meeting. At such meeting the members shall elect by majority vote, such member or members of the Board of Directors as they shall be entitled to elect in accordance with the Articles of Incorporation and By-Laws, and transact such other business as may be properly be brought before the meeting.
