VILLAGE ADMINISTRATOR: STEWART- STILL WORKING ON THE TELEMETRY, THE TORNADO BACKED THE TIMELINE UP. THE GOAL FOR POOL OPENING DATE IS SET FOR MAY 31ST, A DAY POOL PARTY IS SCHEDULED FOR THAT DAY. THE WEATHER HAS HELD US UP. STEWART TO PICK UP FLOWER POTS ON FRIDAY, MAY 23RD. THE FLAGS HAVE BEEN HUNG. THE MOWING & WEED EATING HAVE BEEN KEPT UP ON. THERE ARE MULTIPLE PROJECTS GOING ON IN THE VILLAGE, JUST TRYING TO COORDINATE BEFORE THE PAVING BEGINS. THE PAVING PROJECT HAS BEEN PUSHED TO AUGUST 1ST. ODOT WILL START DEPTH REPAIRS SOON. HAD A MEETING ABOUT A NEW MURAL WITH KATE WELLS, STEWART, CHRIS SHEA, STEVE LUBBE, DWAYNE RICHARDS & HIS ASSISTANT. THE MURAL WILL BE ON THE OLD BANK BUILDING ON THE STUCKO SIDE. THE MURAL WILL BE VOTED ON. THE CONTRACTORS WORKING IN THE VILLAGE HAVE ASKED TO STORE SOME OF THEIR EQUIPMENT AT OUR SHOP, THE CCR IS DUE ON JUNE 1ST. 12 LIFEGUARDS ARE HIRED & READY. THE POOL IS IN POOR SHAPE. PICTURES WERE PASSED AROUND TO COUNCIL TO SHOW THE CONDITION OF THE VILLAGE POOL. THERE ARE BIG HOLES, THE FOUNDATION IS SHOT. HOPING TO PUT A BAND-AID ON FOR THIS YEAR, IF UNABLE TO GET FUNDING TO REPLACE THE ENTIRE FLOOR OF THE POOL, THE POOL WONT OPEN FOR THE POOL SEASON 2026. FISCAL OFFICER: MANN- SPECTRUM INTERNET & PHONE SERVICE IS NOW INSTALLED AT THE VILLAGE OFFICE.

EXPENDITURES: REVIEW, MOTION, APPROVAL. MOTION BY DAWSON/MAXIE TO PAY THE BILLS. ALL IN FAVOR VOTE – 4 YEA 0 NAY.

LAW DIRECTOR: KIGER- AN EXPANSION MAP WAS GIVEN IN COUNCIL PACKETS, KIGER & STEWART MET WITH JAIME GENTRY FROM THE OHIO DEPARTMENT OF DEVELOPMENT TODAY AT THE VILLAGE OFFICE. GENTRY OUTLINED TERMS TAX INCREMENT FINANCING & OTHER FINANCIAL DEALS THE COUNTY MADE WITH AMAZON WEBSERVICES. THE EXPANSION MAP SHOWS THE NEW CONSTRUCTION THAT WILL BE ADJACENT TO I-71 & THE VILLAGE ANNEXATION THAT WILL BE DIRECTLY ACROSS FROM THAT. GENTRY SUGGESTS THE VILLAGE COPIES WHAT WAS DONE WITH AMAZON & ENTER INTO SIMILAR FINANCIAL ARRANGEMENTS TO ALLOW THE VILLAGE TO BUILD AT THEIR EXPENSE. WATER & SEWER INFRASTRUCTURE WILL NEED TO CONTINUE, TO DEVELOP THE VILLAGE, THERE ARE MANY DIFFERENT OPTIONS ON ENTERING INTO COOPERATIVE AGREEMENTS WITH THE COUNTY TO BUILD OUT THE VILLAGE SIDE OF THE HIGHWAY, WHILE CONTINUING TO MAINTAIN SERVICES TO VILLAGE RESIDENTS WITHOUT SUBSTAINTLY RAISING RATES. GENTRY IS A GOOD RESOURCE FOR THE VILLAGE. KIGER ENCOURAGES COUNCIL TO MAKE THE MEETINGS IF ABLE. MANN & STEWART WILL MAKE COUNCIL AWARE OF FUTURE MEETINGS. SPAHR- ABLE TO WORK WITH THE COUNTY & HAVE OFFERED THE WATER SERVICE TO THE VILLAGE. DAWSON- ARE THE FUTURE EXPANSIONS ANNEXED IN THE VILLAGE? KIGER- YES, WHEN THE VILLAGE COMPLETES THE ZONING, DAVID MARTIN WILL MAKE ANNEXATION PETITIONS TO THE COUNTY TO BRING THAT LAND TO THE VILLAGE. GENTRY SUGGESTS HAVING ACCESS TO THE COUNTY WELL FIELD WITH A COOPERATIVE AGREEMENT THROUGH THE COUNTY. ON THE SEWER SIDE, THEY NEED US TO THE NORTH. TESTING & EXPLORATION OF A RECYCLED WATER SYSTEM FOR USE OF THE DATA CENTER. VAST NUMBER OF JOBS WILL BE CREATED. KIGER LOOKED INTO HOW MANY RESIDENTS ARE GOING TO WORK AT HONDA BASED ON ZIP CODE 43160 PERIOD JANUARY 2025- MAY 19, 2025 THROUGH JOBS OF OHIO 126 TOTAL RECRUITMENTS & 43128- 52 TOTAL RECRUITMENTS. SPAHR- HOUSING DEVELOPMENT STABILIZED THEIR ROAD BASE WITH CONCRETE PRODUCT. BY OCTOBER, 34 HOUSES SHOULD BE FINISHED. THEN THE NEXT GROUP TO FOLLOW. STEWART- 701 TOTAL ADDRESSES WHEN COMPLETELY FINISHED.
