VILLAGE ADMINISTRATOR: STEWART- HANDOUT WAS GIVEN IN COUNCIL PACKETS. STEWART- SCOTT SIMS FILED HIS FINAL PLAT & PAID ALL OF HIS FEES. OHIO RURAL WATER (ORW) CAME TO THE VILLAGE & ASSISTED AT A RESIDENT PROPERTY ON 384 YORKSHIRE. A COMPLAINT WAS RECEIVED ABOUT SEWER BACKING UP & A PLUMBER TOLD THE RESIDENT IT WAS ON THE VILLAGE SIDE, ORW RAN A CAMERA DOWN 45' PAST THEIR RESIDENCE THE VILLAGE SIDE WAS CLEAR. LOOKED IN THE RESIDENT LATERAL IT WAS FILLED WITH TREE ROOTS. STEWART HAD THE RESIDENT COME LOOK AT THE CAMERA. CONTACT INFO WAS GIVEN TO THE RESIDENT TO GET IT TAKEN CARE OF, STEWART FOLLOWED UP WITH THE RESIDENT WHO LIVES AT 115 WOODSVIEW CT., THE VILLAGE IS UNABLE TO GET ANY EQUIPMENT IN HIS BACK YARD. THE VILLAGE IS UNABLE TO HELP HIM IN ANYWAY. STEWART FOUND OUT THE VILLAGE HAS 3 LARGE SINKHOLES ON MCARTHUR RD. FROM EROSION, RECEIVED A QUOTE OF AT LEAST \$30,000.00 TO SANDBLAST THE POOL TO REMOVE THE OLD RUBBER PAINT. LOOKING AT OTHER OPTIONS. THE SOFA AT STATE ST. IS GONE. A NUISANCE LETTER WENT TO 40 S. MAIN ST. TO REMOVE THE CAR WITH THE FLAT TIRES OFF THE STREET. THE BOAT AT 249 WOODSVIEW DR. IS GONE. THE CAMPER ON WOODSVIEW DR. IS GONE. ORW IS GOING TO COME BACK & HELP EXERCISE VALVES. ORW IS ALLOWED TO COME THREE TIMES A MONTH TO HELP. AT THE REST AREAS, THEY'RE STILL HAVING ISSUES WITH BROWN SLUDGY WATER. SETTING UP A TIME TO MEET & FLUSH. KIGER- ARE THERE HYDRANTS OUT THERE?
