MINUTES: OF THE 10 APRIL 2025 MEETING WERE APPROVED MOTION BY DAWSON/MAXIE VOTE - 6 YEA 0

VISITORS/CITIZENS: RESIDENT LARRY GATHERS, RESIDENT SUSAN KEITH, RESIDENT PAM ROBINETTE, SCOTT SIMS OF SIMS CONSTRUCTION

ROBINETTE- NOT PLEASED WITH HOW THE REMOVAL OF THE TREES FROM THE DOWNTOWN AREA HAS BEEN HANDLED. CITIZENS WEREN'T ASKED. BIRDS WERE LIVING IN THE TREES NESTING THERE. BIRDS WILL NOW BE IN THE EAVES OF PEOPLES HOMES. SEES NO INDICATION OF WHERE THE SIDEWALKS ARE BEING DESTROYED DUE TO THE TREES. COULD'VE BEEN ADDRESSED DIFFERENTLY. STEWART-DISCUSSED BY COUNCIL MULTIPLE TIMES, UNFORTUNATELY NO ONE COMES TO COUNCIL MEETINGS. ROBINETTE- NOW PUT IN FLOWERS THAT WILL NEED TO BE MAINTAINED. WHO WILL DO THIS DAILY? WILL HELP BUT NOT DOING IT ALL THE TIME. STEWART- PLAN TO GET LIVE TREES & PLANT AT THE PARK. THE TRUNKS WAS OUTGROWING THE IRON GRATE. KEITH- WHAT HAPPENED WITH THE BEAUTIFICATION? WANTED TO BE A PART OF THAT COMMITTEE. STEWART- NO COMMITTEE HAS BEEN FORMED YET. KEITH- STILL HAVE PLANS OF HAVING THIS COMMITTEE? KIRCHNER- YES. KEITH- ARE THEY ANY MORE MAJOR WATER PLANS TO CAUSE THE WATER TO BE OFF AGAIN? STEWART- 5 WATER VALVES REPLACED IN THE PAST 2 WEEKS. THIS IS TO ELIMINATE SHUTTING OFF SUCH LONG RUNS. WHEN HOOKING THE NEW LINE TO THE CURRENT LINE, WATER MAY BE OFF AGAIN. THE OFFICE ALWAYS SENDS OUT A ONE CALL MESSAGE LETTING THE RESIDENTS KNOW AS SOON AS THE OFFICE FINDS OUT.
