MINUTES: OF THE 14 NOVEMBER 2024 MEETING WERE APPROVED MOTION BY DAWSON/BURNSIDE VOTE - 5 YEA 0 NAY.

VISITORS/CITIZENS: KIRCHNER LIMITED VISITORS/CITIZENS TO 5 MINUTES EACH. JASON LANGLEY WITH LANGLEY REALTY, CHIP TATE RESIDENT IN THE VILLAGE, PATTY & RICH DAWSON RESIDENTS IN THE VILLAGE, BARB ANDERSON WITH CT CONSULTANTS & BILL GLISPIE JEFFERSON TOWNSHIP FIRE CHIEF. LANGLEY- CERTAIN LOTS ON VINE ST. ARE IN THE TOWNSHIP. LANGLEY BROUGHT A MAP MARKED IN RED SHOWING COUNCIL. LANGLEY HAS A LOCAL BUILDER THAT IS INTERESTED IN PURCHASING THESE LOTS, HOWEVER HE NEEDS VILLAGE UTILITIES. LANGLEY IS APPROACHING COUNCIL TO SEE IF INTERESTED & TO GET THIS PROCESS STARTED. THE BUILDER WANTS TO BUILD 6 HOUSES STARTING IN THE SPRING. THE HOUSES WILL BE 3 BEDROOMS, 2 BATH, 2 CAR ATTACH GARAGE.1,400 SQUARE FT. OF LIVING SPACE. FOR 2 STORY HOMES 2,000 SQ. FT. IN ORDER TO DO THIS, NEED VILLAGE UTILITIES. THE BUILDER UNDERSTANDS THE COST OF THE TAP FEES. THE HOUSES SOLD IN JEFFERSONVILLE WILL BE AROUND \$230,000.00-\$245,000.00. STEWART WILL GET A PLANNING MEETING SCHEDULED. MRS. DAWSON-YOU'RE ADDING A LOT OF HOUSES, IS THE VILLAGE GOING TO WORK ON SOME TYPE OF ANALYSIS WITH THE IMPACT ON UTILITIES? KIRCHNER- VERY AWARE OF OUR CAPACITY. MRS. DAWSON-CAN YOU DISCLOSE TO THE RESIDENTS WITHIN THE VILLAGE, WOULD LIKE TO SEE THOSE TYPES OF REPORTS.

TATE- INTRODUCED HIMSELF TO COUNCIL, GREW UP IN THE VILLAGE & HAS RECENTLY JUST MOVED BACK, LIVES IN TOWN AT 3 JUPITER ST. WOULD LIKE TO GET TO KNOW HOW THINGS ARE WORKING. KIRCHNER- WELCOME TO COME TO THE COUNCIL MEETINGS, EVERY 2ND & 4TH THURSDAY AT 7:00 PM. MRS. DAWSON- DOES NOT SUPPORT ON SITE CONSTRUCTION WORKING 7 DAYS A WEEK FROM 7:00 AM-8:30 PM. SCOTT SIMS IS A GOOD DEVELOPER. SIMS HAD THE WORKERS FILL UP THEIR TRUCKS SO THEY'RE NOT DOING IT RIGHT NEXT TO HER HOUSE AND WERE ABLE TO WORK FURTHER OUT IN THE FIELD. HER HOUSE IS FILTHY ON THE OUTSIDE BECAUSE OF THE CONSTRUCTION. KIRCHNER- DID YOU BRING THIS UP TO SIMS? MRS. DAWSON- SIMS IS AWARE. MRS. DAWSON CANNOT GIVE UP HER ENTIRE SUMMER, SHE WANTS RESTRICTIONS. COUNCIL SHOULD PUT RESTRICTIONS. MAYOR WILL TAKE UNDER ADVISEMENT. MRS. DAWSON HAS FILED COMPLAINTS ABOUT THE FIELD ACROSS FROM HER HOUSE THAT HAS ONLY BEEN MOWED ONE TIME. SPAHR- A COMMITMENT HAS BEEN SET WITH A GUY TO BAIL IT FOR NEXT YEAR.
