MINUTES: OF THE 27 FEBRUARY 2025 MEETING WERE APPROVED MOTION BY DAWSON/MAXIE VOTE - 5 YEA 0 NAY.

VISITORS/CITIZENS: KRISTY BOWERS PRESIDENT OF WASHINGTON COURT HOUSE CHAMBER OF COMMERCE, DARYL ROBERTS RESIDENT IN THE VILLAGE & SCOTT SIMS WITH SIMS CONSTRUCTION. ROBERTS- LIVES IN THE VILLAGE ON WOODSVIEW CT., WANTING TO DISCUSS THE INFRASTRUCTURE GOING ON IN THE VILLAGE. ROBERTS HAS BEEN HAVING SEWER ISSUES AT HIS HOME SINCE 2023; HIS SEWER LINE COLLAPSED. ROBERTS PAID TO GET THIS FIXED, HOWEVER THE LAST 30' IS UNABLE TO GET FIXED DUE TO THE UTILITY COMPANY, TELEPHONE COMPANY & INTERNET COMPANY HAVING THEIR LINES LAID ACROSS THE SEWER LINES. THE CONTRACTOR ROBERTS HIRED HIT THE LINES BECAUSE THEY WEREN'T MARKED BY THE UTILITY COMPANIES. ROBERTS HAS BEEN WITHOUT THE USE OF WATER FOR A WEEK BECAUSE HE IS UNABLE TO FINISH THE LINE. ROBERTS IS TRYING TO FIGURE OUT WHAT TO DO. THE PREVIOUS MAYOR AND VA WOULDN'T HELP. ROBERTS NEEDS TO FIX HIS LINE. KIGER-EVERY CONTACTOR IN OHIO, WHEN THEY DIG IN THE RIGHT OF WAY, IS REQUIRED TO CALL THE OHIO AGENCY CALLED OUPS. WAS THIS DONE? ROBERTS- YES IT WAS; OUPS FAILED TO MARK THE BACK. WHEN THE CONTRACTOR CAME BACK TO TIE INTO THE VILLAGE SEWER LINE, THE CONTRACTOR HIT THE LINES. ROBERTS- UNABLE TO SHOVEL IT'S 15' FROM WHERE THE LINE IS. THE LAST PIECE OF THE SEWER PIPE HAS NOW COLLAPSED CAUSING ROBERTS TO BE WITHOUT THE USE OF WATER. NO CONTRACTOR WILL TOUCH THIS. KIGER- UNABLE TO COMMENT. KIGER & KIGER HAS REPRESENTED ROBERTS IN THE PAST. ROBERTS IS UNABLE TO FIX BECAUSE UTILITIES CROSS OVER HIS LINE & UNABLE TO DIG DUE TO HEALTH MATTERS. KIRCHNER- ARE YOU FINANCIALLY ABLE TO PAY? ROBERTS-YES, IN 90 DAYS. JUST TRYING TO GET SOME RESOLUTION. STEWART & VILLAGE SUPERINTENDENT WILL COME LOOK AT IT. STEWART WILL CHECK TO SEE IF THE VILLAGE IS ABLE TO WORK WITH THE UTILITIES. STEWART WILL THEN ASK FOR COUNCIL APPROVAL OF ANY SOLUTION STEWART HAS CAME UP WITH, STEWART WILL KEEP IN CONTACT WITH ROBERTS.
