EMPLOYEES: ANGELA MANN & STEPHANIE STEWART WERE PRESENT. LAW DIRECTOR DAVID KIGER WAS PRESENT.

MINUTES: OF THE 27 MARCH 2025 MEETING WERE APPROVED WITH CORRECTIONS MOTION BY BURNSIDE/DAWSON VOTE - 5 YEA 0 NAY.

FINANCIALS: MOTION BY BURNSIDE/MINSHALL FEBRUARY 2025 FINANCIAL STATEMENTS WERE RECEIVED & REVIEWED VOTE - 5 YEA 0 NAY.

VISITORS/CITIZENS: RESIDENT THOMAS JONES, RESIDENT KAYLIN TABOR & JON TABOR TABOR LIVES AT 18 JANES ST. THE TOILET HAS BEEN UNABLE TO FLUSH OVER A WEEK DUE TO ALL OF THE RAIN. TABOR HIRED A PLUMBER OVER A YEAR AGO, THE PLUMBER SAID THE ISSUE IS ON THE VILLAGE SIDE. WHEN TABOR CONTACTED THE VILLAGE, SHE WAS TOLD TO REACH BACK OUT WHEN THERE WAS HEAVY RAINFALL. TABOR FINALLY REACHED OUT TO THE VILLAGE AFTER HEAVY RAINFALL & WAS TOLD SOMEONE WOULD COME CHECK. NO ONE FROM THE VILLAGE EVER DID. TABOR WAS TOLD FROM THE VILLAGE THIS IS AN INFRASTRUCTURE ISSUE. TABOR CALLED THE OFFICE LAST WEEK REQUESTING AN ADJUSTMENT ON HER WATER BILL BECAUSE TABOR IS WITHOUT THE USE OF THE SEWER UTILITY. THE NEIGHBORS ON THE SAME SIDE OF THE STREET ARE DEALING WITH THE SAME ISSUES. THIS IS A SANITARY ISSUE FOR HERSELF, HUSBAND AND THEIR TWO SMALL CHILDREN WHO LIVE IN THE HOME. KIGER- HAS THE VILLAGE SCOPED THIS? STEWART- EMPLOYEE JEFF TAYLOR WENT & LOOKED AT THE MAINS. JON TABOR- IT'S NOT BACKING UP INTO OUR HOUSE, THERE IS JUST NO PRESSURE. KIGER- THE MAIN ON THE VILLAGE SIDE IS NOT MOVING QUICK ENOUGH TO ADVANCE. KAYLIN TABOR- WHAT TO DO UNTIL THE NEW LIFT STATION IS BUILT? USED TO BE ABLE TO GET BY, HOWEVER THE PAST 2-3 WEEKS HAVEN'T EVEN BEEN ABLE TO FLUSH THE TOILET. KIGER- HAVE YOU HAD YOUR SEWER SCOPED? WHO WAS THE PLUMBER? TABOR- UNSURE, SOMEONE LOCAL. IT'S BEEN OVER A YEAR. KIGER- NOT QUESTIONING YOU, JUST WANTING TO SEE IF THE VILLAGE CAN COORDINATE WITH YOUR PLUMBER. THE VILLAGE WILL HAVE THIS SCOPED ON THE VILLAGE SIDE. STEWART WILL GET WITH OHIO RURAL WATER TO GET THE SEWER LINE SCOPED, CAN ONLY SCOPE VILLAGE INFRASTRUCTURE. WILL KEEP THE TABOR FAMILY UPDATED. STEWART WILL EITHER SEND THE VIDEO OF THE SCOPE VIA EMAIL OR CAN COME & WATCH THE VIDEO. TABOR- IF THIS IS A LIFT STATION ISSUE, WHAT IS TABOR TO DO? STEWART- WAITING ON THE EPA. KIRCHNER- THE VILLAGE WILL DO THEIR BEST TO COME UP WITH SOMETHING.

AN ADJUSTOR CAME OUT. A NEW ROOF ON THE LIFT STATION HAS BEEN REPLACED. A NEW PANEL HAS BEEN ORDERED. A NEW BUILDING WAS LOOKED AT. QUOTES ARE IN FOR A NEW BUILDING. DAVID MARTIN MET WITH KIGER; THE POWER PLANT IS TO LIE ADJACENT TO THE COE PROPERTY & HONDA PLANT, THE TOTAL PROPOSED LAND TO BE ANNEXED IN IS AN ADDITIONAL 1,000 ACRES. KIGER-THEY WERE TOLD TO BRING WATER. IF WATER INFRASTRUCTURE IS BUILT, THE VILLAGE WILL WANT TO BENEFIT FROM THAT. MARTIN PROPOSED THE VILLAGE COULD ACCESS UP TO 30% OF THAT SUPPLY. KIGER INFORMED IT WOULD REQUIRE A LOT OF ABOVE GROUND STORAGE, 2-3 NEW TOWERS. A NET ZERO EXPENSE TO THE VILLAGE. MARTIN PROPOSED A POSSIBLE JEDD. KIGER- WAY TO GO WOULD BE TAX INCREMENT FINANCING OR WHATEVER IS GOING TO BENEFIT THE VILLAGE. BONDING 30%. VILLAGE WILL BE IN CONTROL WITH NO REVENUE OUTGOING. A MINIMUM SERVICE PAYMENT. DETAILS ARE YET TO COME. KIGER HAS A MAP OF THE PROPOSED AREAS, WILL EMAIL TO MANN TO DISTRIBUTE TO COUNCIL. KIGER KEEPS THE VILLAGE COMPREHENSIVE PLAN IN MIND. ALL THE NOISE, LIGHT, CLUTTER, HEIGHT INCREASE IN BUILDINGS. THE PLANNING COMMITTEE WILL NEED TO MEET. KIGER HAS A COMPREHENSIVE LANDSCAPING ORDINANCE. MAIN ST.? STEWART- YES, JACOB WYMER DROPPED A LETTER IN THE VILLAGE DROPBOX. HIS LETTER STATED WYMER WOULD BE MOVED OUT ON MAY 4, 2025. DAWSON- THE VILLAGE WEBSITE HAS BEEN UPDATED. HAVE THE CO-MANAGER POSITIONS BEEN FILLED AT THE POOL? STEWART- YES. DAWSON-NO CHANGE IN TRAFFIC PATTERN ON JANES ST. LAY SPEED BUMPS. MOTION BY DAWSON/MAXIE TO INSTALL SPEED BUMPS ON JANES ST. VOTE - 6 YEA 0 NAY. STEWART- WILL WORK ON THE SPEED BUMPS ASAP. BURNSIDE- HAVE THE REST AREAS RECEIVED THEIR WATER BILLS? MANN- YES. BURNSIDE- ORDER \$50.00 FROM SAMS CLUB THEY WILL DELIVER.
