## TOURNAMENT RULES

1. Doubles team shall consist of 2 bowlers (18 years or older). Can have same or different partner for each event, can participate in 1, 2, and/or 3 as each tournament is held as a standalone tournament.
2. Team average will be the average of their **COMPOSITE AVERAGE FROM 2024-2025 SEASON**. If you do not have an average from 2024-2025, you will come in with a scratch of 230. Handicap 90% of 230 for 6 game series  
\* Example (Bowler "A" 200 Ave – Bowler "B" 210 Ave = Team average 205)
3. Failure to use correct average or make correction prior to completion of the first game of a series shall disqualify score if submitted average is lower than correct average. Prize winnings shall be based on the submitted average if it is higher than the correct average
4. 6 games total for qualifying round (will move 1 pair to the right after each game), Top 16 advance, cut to 8, cut to 4 for final round. Each round will be a 2-game total (will reset after each round), based on 36 entries, and will adjust based on actual entries each tournament.
5. All decisions of Tournament Management are final unless an appeal is filed with 600 or 700 Club Directors.
