## Health and Skincare I

### **First Year:**

The first year training course provides the learner with an in-depth understanding of the primary theoretical and practical aspects of skin and body care therapies.

#### Duration: Starting:

One year full time January 2022/2023

On completion of the first year, learners will be able to perform full skin and body therapies utilising the a selection of Cosmetic Products, basic electrical apparatus, apply make-up suitable for all occasions, perform manicures, pedicures and waxing techniques and Nail Technology Treatments to suit the client's needs.

#### Entrance requirements:

Learners who want to enrol on the 2 year Diploma Health and Skincare are required to be in possession of Matric (Grade12) certificate .

The minimum age requirement will be 16 years of age.

Learners need to contact the academy to book an enrolment interview with the registrar where all the courses and procedures will be explained to the learner and their sponsor. Online enrolments can also be accepted.

#### First Year: Case Study Requirements:

#### During your first year of training you will be required to complete case studies

Treatment Evidence/Portfolio of Evidence. This means that you are required to provide evidence of treatments that you have performed on clients during your training under the supervision of your Lecturer who will monitor the quality of your treatments in order to ensure that they meet the programme criteria

• The criteria are detailed on the Treatment Evidence Guidance Forms.

They are graded Pass or Refer

• You will need to complete a Client Consultation Form as evidence that you performed the required number of treatments during your training (see the table below ) as they form part of your internal assessment for the qualification.



Facials:	To include
5 clients to receive a full facial treatment 5 times each. Full facial includes: double cleanse, tone, exfoliate, steam, tinting, brow shaping, massage, mask, moisturise, SPF and home care. Make-up: 5 clients to each receive: one day, one evening, one bridal make-up, one special occasion (glamour) and one other (black and white photographic) make-up. Over and above these 5 clients anther 2 clients are to receive 2 mature make-ups each. ## **Second Year:**

The second year diploma is an extension and development of the first year programme. This course includes a combination of Spa Therapies, Swedish Massage, Advanced Massage Techniques: Hot stone Therapy & Indian Head Massage, Advanced facial and body Electrical treatments and Figure Diagnosis.

Duration:One year full timeStarting:January 2022/2023Time:Monday to Friday (08:00 to 15:00)

#### Course Objectives:

The course forms a natural progression where the students will be exposed to dealing with the more advanced therapeutic requirements of clients that need more complex therapies. Spa Therapies , sales, marketing and practical clinic experience is an important aspect which the learners gain during this year. This will create more job opportunities and build onto their Business plan developed in their first year of studies and expand their entrepreneurial skills.

Case studies for each core subject are done on premises with assistance of facilitators (minimum two afternoons/week)

#### Second Year: Case Study requirements:

Body Electrical treatments : 4 clients to each receive 10 full treatments, with 1 objective in each case. i.e. Cellulite: treated with the galvanic and the pre- heating technique (hot shower) i.e. Fat loss: treated with gyratory massage unit and a pre-heating technique (steam bath) i.e. Muscle toning/firming: treated with the faradic and pre-heat The same set of machines must be used throughout the course of the treatments in order to achieve dramatic results. Full treatment includes: figure diagnosis, range of electrical equipment, pre-treatments and massage. Facial Electrical treatments : Evidence of treating 5 clients using a minimum of 2 suitable facial electrical treatments per client.
