SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

Move to fresh air. Keep at rest in a position comfortable for breathing. If breathing is difficult, trained personnel should administer emergency oxygen if advised to do so by Poison Centre or doctor. **Skin Contact**

SECTION 5. FIRE-FIGHTING MEASURES

Extinguishing Media

Suitable Extinguishing Media

Carbon dioxide, dry chemical powder, appropriate foam, water spray or fog.

Unsuitable Extinguishing Media

Water is not effective for extinguishing a fire. It may not cool product below its flash point.

Specific Hazards Arising from the Chemical

Reactive flammable. Heating increases the release of toxic vapour.
