# **INSTRUCTIONS**

### **BUSINESS PRIVILEGE TAX**

The Business Privilege Tax of 1.5 mills is imposed on the "GROSS RECEIPTS" of Persons, Businesses, Trades, Occupations and Professions operating a business within the Township.

### **MERCANTILE TAX**

The Mercantile Tax is to be paid on the 'GROSS VOLUME OF BUSINESS" from the sale either at retail (1.5 mills) or wholesale (1.0 mill) of any goods sold by any "DEALER" operating a business within the Township.

#### PARTIAL YEAR

If the business has not been operating for a full year then the Tax will be on the Gross Receipts for the period in the year that the business has been operating. The Estimate Tax shall be computed by dividing the Tax by the number of months in business and then multiplying by twelve (12).

### **LICENSE**

A separate license shall be required for each place of businesses within the Township. If a firm is located outside the Township but providing services subject to the Business Privilege Tax within the Township, that firm shall be required to obtain a license.
