

## Screenwriters Shop Service Marketing Contract



The Service Provider verifies he/she is competent enough to do the work specified on the website. He/She understands it needs to be done in a timely manner and will refund any money from the consumer for services not rendered.

The Service Provider will charge a fair price for the services rendered. All prices must be provided to Screenwriters Shop. They will be posted on the site. Prices may be changed quarterly. It is of utmost importance that the Service Provider promptly contacts those who request services within 3 business days. If, for any reason, he/she feels unable to perform the service, it is requested that he/she refer the customer back to the website Screenwriters Shop to help find someone who can meet their needs. Failure to return customer emails and requests (within a reasonable time) will be considered an option for stopping the membership. No refunds will be given if the membership is ceased due to the Service Provider's failure to fulfill this contract's obligations. All of the Service Providers who represent themselves on this website must be over the age of 18 and live in the United States. No outsourcing or secondary sourcing is permitted. No spamming.

The Service Provider may opt to move up the levels at any time after 2 months of the contract. All payments will be credited toward the next level. Suppose the Service Provider registers to perform a service and does not have the qualifications. In that case, he/she may opt to register for a different service.

[January-March, April-June, July-Sept, Oct-December]. The contract begins at the time of the payment for the quarter in which the contract is signed.

Screenwriters Shop must keep an active website under a current business license within the United States. They will manage the website according to parameters and keep files related to hits/month, sales, and marketing expansion.

## Screenwriters Shop Website Marketing Contract for Material

- The Author may select to mail copies directly to the customer via a link provided [website, Face Book, or email].

Filling orders within a week of the customer's order is recommended. Unfilled orders will result in forfeiting contract obligations, and the Author's book will be removed from website. Money will not be refunded for failing to promptly fulfill a customer's order. All of the book titles must be wholesome content or suitable for those under the age of 18.
