Call meeting to order- Mike Zagar called the meeting to order at 2:03pm.

Previous Meeting Minutes- The minutes from the December 2019 meeting were reviewed. Susan made a motion to approve the minutes as presented, Wendy seconded the motion, motion carried unanimously.

Treasurer's Report – At the end of 2019 there is an additional \$6,338 in the budget. Mike L suggested leaving the additional funds in the checking account as a we may have some additional costs associated with removing dead and damaged trees along Wyoming and Maple, all in agreement. The amount of \$5,500 will be placed in the Reserve Account per the 2019 budget. Late fees will be increased to 5% of the assessment per month starting March 1, 2020. The late fee will stay at \$5 for the February late fee. Mike made a motion to increase the late fee per above. Wendy 2nd the motion, motion carried unanimously. Heather will draft a letter and send to the Board for approval. Mike made a motion to approve the financial reports Susan 2nd the motion, motion carried unanimously.

- a. **Tree planting project on Wyoming and Maple-** The project will resume in the Spring of 2020. Utility easements will be marked on WYOMING after the snow thaws. Entire area needs to be marked.
- b. **Remove ailing trees on Maple as needed-** This project will be done Spring 2020. Kasey suggested having an arborist out to look at the trees for suggestion. Kasey and Susan will work together for this project.
- c. **Arena Loop draining pool into common area-** No response or payment as of meeting date. Account has been turned over to Scott Poorman to send letter and collect funds owed.
- d. Lattice on 4X4 posts visible from Maple- Structure is still in place. Will ask owners for a completion schedule.
