Acknowledgment of Risk & Responsibility:

I, the undersigned, acknowledge that participation in a chartered boat experience with Tiki Tom's Dog Barge involves inherent risks, including but not limited to the risks associated with being on open water, weather conditions, boat movement, and interactions between dogs and people. I voluntarily assume all risks related to my participation and that of any dog(s) accompanying me.

I understand and agree that I am fully responsible for my own safety and behavior while on the boat. I understand and agree that I am also fully responsible for the safety, behavior, and actions of my dog(s) at all times. I understand that my dog(s) and I exit the boat at our own risk.

I must keep my dog(s) under control to prevent injury to people, other dogs, or property. I assume full responsibility for any damages or injuries caused by me or my dog(s) to any person, animal, or property.

Tiki Tom's Dog Barge is a BYOB (Bring Your Own Beverage) experience, and I am responsible for consuming alcoholic beverages responsibly. If at any point my behavior or my dog(s) behavior is deemed unsafe, inappropriate or disrespectful to the Captain or First Mate, I understand that the trip will end immediately with no refund.

Weather Condition Acknowledgment and Waiver

I understand that weather and sea conditions can be unpredictable and change rapidly. The safety of all passengers and crew is the top priority. The captain has full authority to delay, modify, or cancel a charter due to weather or sea conditions. I understand that even if a charter proceeds, the weather or sea conditions might not be ideal (e.g., rain, high winds, rough seas).

I voluntarily choose to proceed with the charter, understanding and accepting the potential weather-related risks. I agree to hold Tiki Tom's Dog Barge harmless from any claims, liabilities, or injuries that may arise due to adverse weather conditions, including but not limited to, seasickness, injury, or canceled activities. I understand the company's refund or rescheduling policy.

Release of Liability:

I release and hold harmless Tiki Tom's Dog Barge, its owners, employees, affiliates, and vessel operators from any and all claims, liabilities, damages, injuries, or losses arising from my participation or my dog's participation in this charter experience. This release extends to any claims arising from negligence, weather conditions, accidents, equipment failure, or interactions between passengers and animals.

Medical Treatment Authorization:

In the event of an emergency, I authorize Tiki Tom's Dog Barge to seek medical or veterinary treatment for myself and/or my dog(s) if deemed necessary. I agree to assume all financial responsibility for any such treatment.

Photo & Media Release:

I grant permission for Tiki Tom's Dog Barge to use photographs or video footage taken during the charter for promotional purposes, including social media, marketing materials, and the company website.
