Dealer agrees that it shall complete all necessary forms to authorize and otherwise to accommodate such credit checks within ten (10) days following Elite Cargo's written request. Dealer acknowledges and agrees that any past due balances shall bear interest at the rate of 1.5% per month, or the maximum rate permitted by applicable laws. Dealer further acknowledges that in the event that any indebtedness is placed into the hands of an attorney for collection and/or a lawsuit is instituted to collect said indebtedness, or any portion thereof, Dealer, along with the Guarantor(s) named herein, agree and promise to pay all costs and expenses of collection, suit or other legal action, including, but not limited to, all reasonable attorney's fees and collection costs incurred, as provided by law.
