

Founders Credit Programme Terms

The VyntX Founders Credit Programme is a limited-time promotional initiative designed to reward our earliest supporters and customers.

1. Eligibility

The Founders Credit Programme is available only to users who register through the official VyntX Early Access programme and meet the eligibility criteria set out below.

Founders Credit applies exclusively to the Vision Core Business Plan and is not available on the Vision Core Contractor Plan or any other promotional plans unless expressly stated by VyntX Intelligence Ltd.

2. Early Access Validators

Users selected by VyntX to participate in the Controlled Validation Programme as Validators will receive a €50 monthly Founders Credit.

The credit remains available for as long as the qualifying Vision Core Business subscription remains active and in good standing.

Validator status is granted solely at the discretion of VyntX Intelligence Ltd.

3. Early Access Users

Users who register for Early Access but are not selected as Validators may qualify for a promotional Founders Credit.

Launch Offer

Customers who register before the official commercial launch and activate their first paid Vision Core Business subscription will receive a €50 monthly Founders Credit for 120 consecutive days from the date of subscription activation.

Extended Launch Offer

Customers activating their first paid Vision Core Business subscription within the first 90 days following commercial launch will receive a €50 monthly Founders Credit for 60 consecutive days from the date of subscription activation.

4. Vision Core Contractor Plan

The Vision Core Contractor Plan is an entry-level commercial offering priced at €199 per month and includes:

- 5 Outputs per billing period
- 50 Drawings per billing period

The Contractor Plan does not qualify for the Founders Credit Programme and does not include collaboration features.

5. Credit Usage

Founders Credit may only be applied against eligible VyntX usage charges.

Current standard usage pricing is:

- 1 Additional Output: €20
- Additional 5 Drawings: €10

Unused Founders Credit expires at the end of each applicable billing period and cannot be accumulated, transferred, refunded or exchanged for cash.

6. Business Account Eligibility

Founders Credit is granted per qualifying business account and applies only to the legal entity that registers and maintains an eligible Vision Core Business subscription.

Founders Credit is non-transferable and may not be shared, assigned or extended to any parent company, subsidiary, affiliated company, sister company, branch, franchise, joint venture or any other related legal entity unless expressly agreed in writing by VyntX Intelligence Ltd.

Each eligible legal entity may receive one Founders Credit entitlement only.

Where multiple accounts are created by, or on behalf of, the same legal entity or a group of related entities, VyntX Intelligence Ltd reserves the right to determine eligibility and limit promotional benefits to a single qualifying business account.

7. Subscription Requirement

Founders Credit becomes active only after:

- successful payment of the first qualifying Vision Core Business subscription; and
- the subscription remains active and in good standing.

If the qualifying subscription is cancelled, suspended, terminated or becomes overdue, eligibility for Founders Credit immediately ceases.

8. Change of Ownership

Founders Credit remains attached solely to the qualifying business account and is not transferable following any sale, merger, acquisition, restructuring or other change in ownership or control of the business unless expressly approved in writing by VyntX Intelligence Ltd.

9. Abuse Prevention

VyntX Intelligence Ltd reserves the right to withdraw or refuse Founders Credit where it reasonably believes that:

- duplicate or fraudulent registrations have been created;
- promotional benefits are being abused;
- false information has been provided;
- these Terms or the VyntX Terms of Service have been breached.

10. Programme Changes

The Founders Credit Programme is a limited promotional initiative.

VyntX Intelligence Ltd reserves the right to amend, suspend or discontinue the programme for future participants at any time.

Credits already granted to eligible Validators or qualifying Early Access Users will continue only in accordance with these Terms, provided the qualifying subscription remains active and all eligibility requirements continue to be met.
