6. Unless otherwise agreed to in writing, ASWS makes no warranty of any kind, either expressed or implied, relating to services rendered or products sold.
7. Customer's financial condition is satisfactory and can meet all financial obligations. There are no lawsuits or judgements against Customer. The above information is for the purpose of obtaining credit and is warranted to be true. Customer authorizes ASWS, or any credit bureau or other investigating agency employed by ASWS, to investigate customer's credit and financial responsibility.
